# FOUNDER'S STATEMENT

Nearly ten years ago, in March 2016, I established a foundation dedicated to addressing the systemic challenges of our time. The idea was to create spaces where thinkers from the humanities and social sciences could work across disciplines, free from their academic obligations, and develop interventions aimed at advancing societal progress. In an era when ecological and social systems are visibly beginning to collapse, I believed this to be a significant contribution to the public good.

In the early phase, we established four research centres at the University of California, the University of Cambridge, Humboldt University in Berlin, and Ca' Foscari University of Venice. Beginning in 2021, the foundation operated its own Institute in Hamburg, where around 35 international fellows could live and work.

Much was accomplished during this time. We initiated numerous projects, sparked lively debates, and created a network that has grown over the years and which will continue to have an impact. Several of our fellows and partners made remarkable contributions, whose full significance may only be revealed in the years to come.

At the same time, the resources provided and the societal return did not stand in a reasonable proportion to one another, and the goals we had set for ourselves were only partially achieved. Naturally, an experimental initiative of this kind involved a number of conceptual and personal mistakes, for which, as founder and initiator, I bear full responsibility. Collaborating with scholars from the humanities and social sciences was sobering at times. For many, considerations of personal career advancement seem to outweigh commitment to a shared purpose. Interdisciplinary collaboration and teamwork proved difficult to organize, and ideology or wishful thinking occasionally stood in the way of pragmatic, reality-based approaches. Perhaps this helps explain why disciplines whose perspectives are so urgently needed by society often attract less public attention than one might wish.

With this report, THE NEW INSTITUTE bids farewell. I would like to express my sincere gratitude to everyone involved for their dedication, idealism, and support. This extraordinary journey is coming to an end, and we hope that others will find ways to create formats capable of constructively advancing the societal transformation that is so urgently needed.

# DIRECTORS, FOREWORD

THE NEW INSTITUTE dedicated its final collaborative fellowship program to the theme of Re-thinking Capitalism. It is striking how few institutions are devoted to interrogating the foundations, limits, and alternatives to one global system. Consistent with our belief that the humanities are essential to addressing today's interwoven crises, we understand capitalism not merely as an economic form, but as a socio-political practice – one that shapes values, behaviors, and culture. Our starting point is the ambivalent nature of capitalism: it has simultaneously generated immense material wealth, brought millions out of poverty, spurred technological and scientific development while also deepening inequality, promoting mass-scale ecological destruction, and fragmenting societies. We asked whether capitalism as such fundamentally needs to be left behind or whether it can be consistent with social well-being, equality, and ecological stability.

Our six programs probed different dimensions of this system with the aim of illuminating how it can be progressively transformed to serve both people and the planet. Consistent with our overarching mission to overcome the theory-practice gap, we brought together practitioners and academics from different sectors and disciplines. Our international focus is also reflected in our program chairs, who come from Japan, Nigeria, Peru, the United Kingdom, and the United States. This year, our programs were:

The first four programs brought together foundational questions about how capitalism as such works with concrete problems like repurposing financial instruments towards social ends, reforming food supply chains, and supporting shared entrepreneurship. Productive debates emerged across programs about the extent to which we require systems change as well as which practices count as progressive.

In response to the outbreak of war in Ukraine and in the Middle East, we organized a short-term program (Bitter Victory) concerned with the evolution of victory doctrines and their implications for the termination of violence and establishment of peace.

Fellow selection was based on open calls for applications in collaboration with the respective chairs. In addition, 11 individual fellows were invited to contribute to cross-group discussions. A total of 55 fellows (69% academics and 31% practitioners from 20 countries) lived and worked at the Institute in 2024/25.

In a year marked by horrific wars, the global rise of right-wing authoritarian movements, and numerous attacks on free elections, a heated debate erupted among the fellows about the (in)evitability of social, economic and ecological collapse. If collapse is on the horizon, then the approach to bringing about positive social transformation radically changes. Assessments depended not only on individual temperament, but also on regional background. Fellows from comparatively politically stable and relatively wealthy countries were particularly receptive to the collapse theory. As a result, some programs shifted their focus from war economy to dark socialism and from finance imaginaries to collapse finance. But there were also forward-looking successes. For example, the Nigerian government officially adopted the One Kindred One Business Initiative (OKOBI) of the “Africapitalism” program as a national strategy to fight poverty. The “Future of Food” program drafted a report that paves new pathways for achieving a more just and sustainable global food system. The “Planetary Governance” program laid the foundations for the establishment of an International Court of the Environment and a Global Environment

Agency. Even if global developments are not currently moving towards international cooperation, we nevertheless have to prepare for futures where such institutions are necessary to guard against massive human suffering.

The convivial atmosphere created by living, eating, and working closely together fostered mutual understanding and trust, which led to new ideas and collaborations impossible to achieve under less intimate conditions. We observed how lively interaction developed between groups, how expertise was shared, and networks across countries and disciplines were built. Furthermore, numerous references to last year's theme, Commons and Commoning, developed.

In addition to various in-house activities, we organized a series of public events and partner events with the Körber Foundation, the Frankfurt Book Fair, the Thalia Theatre and, together with the weekly newspaper DIE ZEIT and the Bundeskanzler-Helmut-Schmidt-Stiftung, the awarding of the Helmut-Schmidt-Zukunftspreis.

This academic year marks the end of THE NEW INSTITUTE's residential fellowship program. A total of 155 fellows from 27 countries have lived and worked at the Institute. This has resulted in a large number of publications, public interventions, and the establishment of a broad network of global thinkers and practitioners. And it has sown the seeds for a more just and democratic future that will continue to flourish in other places.

Reflections on our experiences forming an international resident fellowship program focusing on trans-sectoral work and concrete outputs for positive change will be offered in a separate publication.

We would like to warmly thank everyone who contributed to and supported the visionary idea of THE NEW INSTITUTE—the fellows, guests, and dedicated staff members who are committed to a better future with their hearts and minds.

We would like to also express our heartfelt gratitude to Erck Rickmers for making this possible through his generous support.

## ERCK RICKMERS

Founder of THE NEW INSTITUTE and Chairman of the Board of Trustees

Erck Rickmers is an entrepreneur, investor, and philanthropist. A serial founder, he has been primarily active in the fields of shipping, real estate, and renewable energy. He holds an MA in Religious Studies from the University of California, Santa Barbara.

In 2016, concerned by the growing mismatch between the scale of global ecological, social, and political crises and the short-termism of prevailing political and economic responses, he founded THE NEW INSTITUTE to reassert the humanities as a critical force in shaping societal transformation. In its initial phase, the foundation established four research centres at international universities.

From 2021 onward, following the COVID crisis, THE NEW INSTITUTE hosted up to 35 international fellows per academic term, working collaboratively across disciplines and sectors. In 2025, the residential fellowship program was discontinued after a strategic reassessment of its institutional form and long-term effectiveness.



## SABINE KUNST

Chairwoman of the Board of the Joachim Herz Foundation

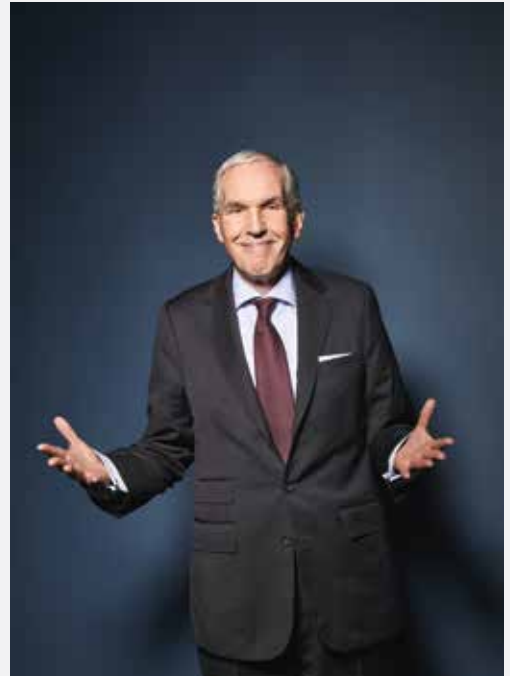
Sabine Kunst is a German engineering scientist, professor, and politician. She holds doctorates in both water management and political science. From 1991 to 2007, she held the chair for Biological Process Engineering at the University of Hannover. Beyond her academic pursuits, Sabine Kunst has actively engaged in science policy and has held key leadership roles at several academic institutions. Between 2005 and 2007, she served as the Director of International Affairs and as Vice President for Teaching, Studies, and Continuing Education at the University of Hannover. She was president of the University of Potsdam from 2007 to 2010 and president of the German Academic Exchange Service (DAAD) from 2010 to 2011. She then moved into politics, serving as the Minister for Science, Research, and Culture in the state of Brandenburg from 2011 to 2016. From 2016 to the end of 2021, she was president of Humboldt University in Berlin. Since 2022, Sabine Kunst has been Chairwoman of the Board of the Hamburg-based Joachim Herz Foundation.



## BURKHARD SCHWENKER

Burkhard Schwenker is an accomplished strategy consultant and advisor. Formerly Chairman of the Advisory Council, Chairman of the Supervisory Board, and long-time CEO of Roland Berger, Burkhard Schwenker transitioned to the role of Senior Fellow at Roland Berger in 2020. A scholar by training, Burkhard Schwenker earned his degree in mathematics and business administration from the University of Bielefeld, and completed his PhD after gaining management experience as an assistant to the Board of PWA AG. Burkhard Schwenker currently serves as Chairman of the Supervisory Board of Hamburger Sparkasse AG and HASPAFinanzholding, and he also sits on the Supervisory Boards of Hamburger Hafen und Logistik AG, Flughafen Hamburg GmbH, and M.M. Beyond his professional and academic commitments, Burkhard Schwenker actively participates in several sociopolitical institutions and foundations, including the ZEIT-Stiftung, the Senat der Wirtschaft e.V., the Hamburg Symphony Orchestra, and Stiftung Hamburger Kunstsammlungen.

# PROGRAMS AND FELLOWS

The current global economy is overshooting planetary boundaries while billions of people continue to live in poverty. Democracy, liberalism, and globalization – once hailed as the unassailable foundations of progress – now stand on shaky ground.

As societies around the world grapple with economic turmoil, widening wealth disparities, and a planet in peril, the problems with this grand structure are becoming impossible to ignore.

Each program analyzed the potential for the economic system to generate social well-being on a global scale within planetary boundaries and identified key points within the system that must be rethought and leveraged for change. These ranged from specific sectors, such as financial markets and global food production, to business design in the national context of Nigeria, to new concepts for restructuring the economic system itself.

We linked foundational questions about how economic markets work, how they should work, and how we should reform our global governance architecture to concrete problems such as how to redirect financial instruments toward social goals, how to reform food supply chains, and how to incentivize markets to promote alternatives. Given the trans-sectoral and international composition of our fellow groups, our programs moved us beyond the stale debate of whether capitalism as such should be supported or abandoned.

Below, we introduce the activities and pursuits of the programs and the associated fellows.\*

# Africapitalism: Shared Entrepreneurship for Economic Development

How are group-owned/community-based businesses economically empowering rural and urban areas in Africa?

## Introduction

In alignment with the 2024–2025 academic theme, the *Africapitalism: Shared Entrepreneurship for Economic Development* program worked on rethinking capitalism by anchoring it in the specific cultural and institutional context—or place—where it operates. While capitalism has been a powerful engine for growth, its emphasis on maximizing shareholder value has often generated negative externalities, including inequality, social fragmentation, and environmental degradation. This program, positioned as an action research initiative, called for a context-sensitive capitalism—one that integrates the resolution of local socio-economic challenges into the core strategy of firms and other stakeholders.

In the African context, persistent challenges, such as poor governance, unemployment, corruption, and poverty, form a systemic cycle that undermines sustainable development. The program proposed Africapitalism as a corrective framework: a locally grounded philosophy that positions the African private sector as a central actor in delivering both economic and social value. Africapitalism emphasizes that market-based growth must be combined with efforts to enhance community well-being, promote inclusive participation, and address structural inequalities.

A key innovation explored by the program was the *One Kindred One Business Initiative (OKOBI)*, introduced by the government of Imo State, Nigeria. OKOBI operationalizes Africapitalism by leveraging traditional kinship systems to promote group-based entrepreneurship. It centers shared ownership, collective responsibility, and wealth creation through culturally resonant structures. By integrating indigenous social systems into modern entrepreneurial frameworks, OKOBI offers both a model for inclusive capitalism and a scalable corporate community economic development strategy, particularly relevant for firms seeking to align with Africa's unique socio-economic realities.

The program contributed to the global debate on transforming capitalism into a more inclusive, ethical, and socially responsive system. It critiqued the dominant paradigm for its detachment from place and its failure to adapt to diverse socio-cultural conditions. By introducing OKOBI, the program brought attention to a critical issue often overlooked in mainstream economic discourse: the role of context in shaping viable development outcomes. It added to a growing body of literature that seeks to decolonize development thinking by demonstrating that indigenous models, when adequately supported, can generate equitable growth. OKOBI stands as a compelling case study of how place-based capitalism can foster economic inclusion and systemic resilience, and help resolve the long-standing tension between capital owners (the bourgeoisie) and labor providers (the proletariat) through a collective employee-ownership model.

This approach is particularly relevant given that decades of conventional economic strategies—often backed by donor institutions—have failed to meaningfully reduce poverty or mass unemployment in many African countries. Structural inequalities, weak institutions, and historic disempowerment remain pervasive. Traditional models of intervention frequently overlook the importance of cultural legitimacy, local agency, and relational social capital, which are fundamental to economic life in African societies.

Africapitalism, and specifically the OKOBI model, offers a corrective lens. OKOBI draws from long-standing traditions of kinship networks and collective action to foster entrepreneurship that is socially embedded and economically viable. Its ability to address structural unemployment, mitigate rural–urban migration, and generate inclusive wealth at the grassroots level affirms its relevance and replicability. In less than two years, over 400 functional microenterprises have been enrolled in the OKOBI database, demonstrating the initiative’s practical impact and scalability. These results also align with broader development goals such as SDG 1 (No Poverty) and SDG 8 (Decent Work and Economic Growth).

Several key milestones during the academic year expanded the program’s scope and impact. One major area of achievement was the interdisciplinary collaboration between fellows from academia and industry. These exchanges enriched the theoretical grounding of Africapitalism and informed the program’s primary output: a practical guide for firms and donor organizations on how to implement the OKOBI model as a community-based development tool.

Field engagement was equally instrumental. Direct, immersive interaction with OKOBI-affiliated businesses offered ethnographic insights into how community entrepreneurship is practiced and sustained. These findings informed the selection of finance models and technology partners for potential replication and scaling. Importantly, these field experiences revealed the types of digital infrastructure needed to support OKOBI's growth—from business management tools to identity verification systems.

To raise awareness and institutionalize key insights, the program invested in strategic public engagement. Research outputs and lessons were disseminated via Nigerian media platforms, helping to shape national discourse around inclusive development and community entrepreneurship. OKOBI's visibility as a viable solution to unemployment and inequality increased significantly as a result.

During the year, OKOBI also gained traction as a catalyst for multi-sector collaboration. Technology providers initiated discussions around building digital platforms tailored to OKOBI enterprises, aimed at expanding access to markets, improving operational capacity, and increasing transparency. Impact investors and development finance institutions began exploring how the initiative could fit into blended finance models focused on job creation and social returns.

Academic partnerships began to take shape, with universities and research centers offering to evaluate the model's impact, refine implementation methods, and develop curriculum modules to support training and knowledge transfer. These collaborations are expected to anchor the model within academic discourse and support its broader institutionalization.

Government and private sector actors likewise expressed interest in the model's potential. Local and state governments are actively assessing how to integrate OKOBI into youth employment, development of Micro, Small, and Medium Enterprises (MSME), and community growth strategies. In parallel, private firms are exploring how the model's principles can strengthen their CSR and sustainability frameworks, particularly in contexts where corporate-community alignment is critical to long-term success.

Looking ahead, the program will move into a second phase focused on institutionalization and scale. This next phase will follow three key strategic directions:

1. **Strengthening Strategic Partnerships:** Formalizing current discussions with technology firms, impact investors, development finance institutions (DFIs), and academic collaborators to co-develop digital infrastructure for OKOBI clusters, enable blended finance, and design impact evaluation systems.
2. **Consulting and Capacity Building:** Developing training and consulting modules based on the implementation guide, targeted at corporate CSR teams, entrepreneurship hubs, and government agencies. These materials will support the rollout of OKOBI-based incubators and accelerators, as well as public sector programs.
3. **Dissemination and Advocacy:** Continuing to share program results, methods, and policy implications through academic publications, media coverage, and conferences. These efforts aim to position OKOBI as a replicable and adaptable model for inclusive development across African contexts.

By championing Africapitalism and advancing models like OKOBI, the program contributes to a more pluralistic and equitable understanding of capitalism—one rooted in context, powered by collective agency, and oriented toward building systems that serve rather than extract from the communities they engage.

Kenneth Amaeshi is a Professor of Sustainable Finance and Governance at the European University Institute. He is currently on long-term leave from the University of Edinburgh, where he is the Chair in Business and Sustainable Development and Director of Scaling Business in Africa. He is also an Extraordinary Professor of Business in Africa at the Graduate School of Business, University of Cape Town, South Africa, and was a Visiting Professor of Leadership and Financial Markets in Africa at the London School of Economics. Kenneth is a leading scholar on sustainable business and finance in the Global South. His research has a very strong interface between business and society, particularly national governments in Africa. Since 2015, he has significantly contributed to developing the intellectual foundations of Africapitalism – an economic philosophy for the development of Africa – and championed its mainstreaming in global academia.

At Tech Herfrica, Imade focuses on bridging the gender digital divide and enhancing access to finance, markets, smartphones, and digital and financial literacy for rural women. Notably, its EquipHer4Growth initiative won the 2023 SDG Digital Game Changers Award in the People's category from the International Telecommunication Union and was nominated for the 2022 WSIS Prizes.

### 04–06.06.25 **Africapitalism Conference**

THE NEW INSTITUTE hosted a high-level international conference on Africapitalism, convened by Professor Kenneth Amaeshi, to explore new models of capitalism grounded in African values, community agency, and shared prosperity. The purpose was to engage a diverse group of global leaders, policymakers, academics, and private sector actors in critically assessing Africapitalism's practical relevance and global resonance.

Conducted under Chatham House Rules to foster open and constructive dialogue, the conference brought together senior representatives from the African Union, the governments of Nigeria and Kenya, the European Commission, the European Investment Bank (EIB), the Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ), and the International Sustainability Standards Board (ISSB), as well as scholars and entrepreneurs.



Participants examined how OKOBI operationalizes the principles of Africapitalism by leveraging kinship networks to build group-owned enterprises that generate employment, reduce poverty, and promote dignity through collective ownership. Discussions also explored its incorporation into Nigeria's Human Capital Development Accelerator Projects and the release of the OKOBI Handbook, a practical guide for scaling community-led enterprise.

The conference marked a significant step in positioning Africapitalism not only as an African response to global economic challenges, but as a viable, internationally relevant framework for reimagining capitalism. It demonstrated how locally rooted, socially inclusive models can offer effective solutions to systemic issues of disempowerment, inequality, and extractive growth.

# Beyond Capitalism: War Economy and Democratic Planning

In the face of the unfolding planetary catastrophe, how can we establish a more egalitarian and sustainable society through a democratically structured “war economy” and a corresponding new notion of freedom and progress?

## Introduction

Like other contemporary intellectual movements addressing climate breakdown and the global polycrisis, the Beyond Capitalism program claimed that these challenges are linked to the structural contradictions of capitalism. What set the program apart was its refusal to stop at critique. It argued that capitalism was not simply inconsistent—it was at the root of the crisis itself and therefore could not offer a solution. “When it comes to the Global North, green capitalism is a myth” was one of the program’s points of departure.

The program drew on Karl Marx and early 20th-century thinkers like Otto Neurath, who questioned the assumed rationality of market economies. It challenged values such as “market freedom” and “eternal economic growth.” Market logic, it said, needs to be restrained, because capitalism prioritizes profit over necessity. The poor become poorer, while wealth continues to accumulate at the top. The climate crisis intensifies these dynamics, creating a state of chronic emergency and bringing about rapid civilizational breakdown.

In this context, the program explored alternatives—ranging from initial steps, such as socializing investment in public infrastructure, to large-scale models like a “war economy”. Estimation of the future also ranged from more optimistic and hopeful narratives (saying that transition is possible), to more pessimistic views marked by disillusionment with the coping techniques that the present can offer us for achieving a better future.

At the heart of this was a renewed conversation about socialism—not as a return to rigid models of the past, but as an open inquiry into what democratic planning could look like in the present. Historical lessons from socialization formed a major part of the program, as did the tensions between centralized planning and bottom-up transformation.

At the same time, the program asked how democracy, freedom, and prosperity—core values associated with the Enlightenment epoch which are worth preserving beyond capitalism—could be redefined to support a more equitable and sustainable future. It examined how a socialist and Marxist framework might incorporate ecological boundaries and a logic of collective care. Could democratic planning exist without authoritarian control? Could it respond to social and environmental needs more effectively than market mechanisms? How can we coordinate increasingly limited resources? These were the central questions that the Beyond Capitalism program brought to the forefront.

From September 2024 to April 2025, the program's core team included Kohei Saito and Aaron Benanav. Both were in the process of writing new books during this time.

Within his book project, Kohei Saito called for immediate decarbonization and examined the foundations and limits of his concept of a war economy—an economy directed by the state rather than the free market, determining what is produced and with which resources. He questioned what kind of socialism is possible in the context of climate collapse and explored whether socialism should rethink its goals and value—from individual emancipation to collective survival. Saito wondered: if we adopt the survival scenario, can principles like equality, solidarity, and justice still serve as the foundation for this form of socialism, even as it unfolds under the harsh conditions of a collapsing world?

Aaron Benanav's project proposed the idea of a multi-dimensional economy—one that reflects the full range of human values beyond economic efficiency, such as meaning, autonomy, care, and connection. He argued that addressing this broader set of priorities demands a restructuring of how economies are governed (or rather coordinated), how firms are evaluated, and how investment decisions are made. Societies, he argued, inevitably face trade-offs among competing goals, but hard choices have to be made. The aim, for Benanav, is not consensus but collective judgment: to build democratic mechanisms through which people can argue, decide, and shape economic priorities together.

Together, Kohei Saito and Aaron Benanav discovered overlapping points in their two models. In February 2025, they were joined by Matthias Schmelzer, who contributed a unique perspective on the possible concrete institutions

for planning beyond growth in the context of ecological limits. They were also supported by guest contributors from two workshops—one on the legitimacy crisis of neoliberal capitalism (November 2024) and another on socializing investment and green transition (March 2025). Discussions also took place with another program from the academic year 2024–2025, Futures of Capitalism. This exchange proved insightful as it opened up ways of thinking about coordinated investment—whether through central planning or venture capital—as scalable, practical alternatives for organizing growth beyond profit. When Melinda Cooper later joined the Futures of Capitalism program, the cross-program overlap became even more prominent. Cooper critiques simplistic anti-finance narratives and she explores how financial tools (like credit) can be redirected toward progressive ends. For Benanav, that spoke to his idea of decentralized planning, for Saito it spoke to his idea of credit guidance for decarbonization.

In May–June 2025, Cédric Durand, Kirstin Munro, Tatjana Söding, and Troy Vettese joined the Beyond Capitalism program. These four new fellows introduced a new routine of intensive weekly reading seminars. There were quite a few insights there. For instance, “ecological knowledge” differs (or should differ) from knowledge produced by the market and capital because it is decentralized, but what does it mean for knowledge to be decentralized? Another example is rewilding: is it a form of coordination with nature or yet another act of usurping it? Or what are the conceptual differences between profitability and productivity, and between a “model of economy” and an “ideology of economy”?

As a next step, Saito, Benanav, Durand, Söding, and Vettese worked on a joint manifesto setting out values of ecosocialism: to liberate nature from capitalist reification, to emancipate humanity by abolishing class society, to demopolize knowledge, and to build a democratic economy governed by needs. They called for rewilding and reduced meat consumption, challenged the commodification of knowledge, promoted meaningful work over alienating jobs, and demanded public, pluralistic control over science, technology, and planning. Maybe democratic survival in the 21st century is possible after all.

## KOHEI SAITO

Associate Professor of Philosophy, University of Tokyo, Japan

September 2024–June 2025

Kohei Saito is an Associate Professor of Philosophy at the University of Tokyo. He received his PhD from Humboldt University in Berlin. He works on ecology and political economy from a Marxist perspective. His latest bestseller, *Capital in the Anthropocene*, has been credited with inspiring a resurgence of interest in Marxist thought throughout Japan. Due to his desire to continue his research on post-capitalism and the Anthropocene, he felt the need to interact with theories and practices that are rapidly developing in Europe, especially in Germany, as a response to the deepening of the climate and economic crises.



## AARON BENANAV

Assistant Professor, Cornell University, USA

Post-Scarcity Economics

September 2024–June 2025

Aaron Benanav is an Assistant Professor in the Department of Global Development at Cornell University. His first book, *Automation and the Future of Work*, appeared with Verso in 2020 and has been translated into 10 languages. Aaron's writing has been featured in *The Nation*, *The Guardian*, *New Statesman*, *Boston Review*, and *New Left Review*. His research interests include technological change, unemployment, economic development, critical theory, and alternative economic systems. Currently, he is working on two book projects. One concerns the idea of a “post-scarcity” economics. The other examines the global history of unemployment. Before he joined Cornell University, Benanav was an Assistant Professor in the Department of Sociology at Syracuse University. He holds a PhD in History from the University of California, Los Angeles, and a BA in History from the University of Chicago. Aaron serves on the editorial board of the *New Left Review* and is a senior editor at *International Labor and Working Class History*.



## CÉDRIC DURAND

Professor of Political Economy, University of Geneva, Switzerland

Prospects for Ecological Planning

May–June 2025

Cédric Durand is a Professor of Political Economy at the University of Geneva. His research focuses on the transformation of contemporary capitalism. In the tradition of Marxism and the French regulation school, he studies unequal development in the context of globalization, the financialization of economies, processes of intellectual monopolization, and the question of planning and eco-socialist bifurcation. In addition to articles in leading academic journals such as *World Development*, the *Review of International Political Economy*, the *Cambridge Journal of Economics*, and the *Socio-Economic Review*, he is the author of *Fictitious Capital: How Finance Is Appropriating Our Future* (2017), *How Silicon Valley Unleashed Techno-Feudalism: The Making of the Digital Economy* (2024), and *Comment Bifurquer: Les principes de la planification écologique* (with Razmig Keucheyan, 2024). He is a regular contributor to the radical online journal *Contretemps* and to *Sidecar*, the blog of the *New Left Review*.



## KIRSTIN MUNRO

Assistant Professor of Economics, The New School for Social Research, New York, USA

Consumption and the Critique of Political Economy

May–June 2025

Kirstin Munro is an Assistant Professor of Economics at the New School for Social Research in New York, where she teaches econometrics, the political economy of gender, and the history of economic thought. Her book, *The Production of Everyday Life in Eco-conscious Households: Conflict, Compromise, Complicity*, was published by Bristol University Press in 2023. Prior to completing her PhD, Kirstin worked as an econometrician on demand forecasting in regulated industries, specializing in the relationship between technological change and demand for products whose prices are not determined by markets. Her current research examines labor, both paid and unpaid, and its relationship to consumption and production processes; the production, distribution, and consumption of energy; and critiques of individual, corporate, and government sustainability efforts. She has been involved in anti-war and leftist movements for over 25 years.



## TATJANA SÖDING

Freelance Journalist, Researcher, Zetkin Collective, Berlin, Germany

Half-Earth Socialism in Germany

Tatjana Söding is a freelance journalist based in Berlin and a researcher with the Zetkin Collective. She received her MSc in Human Ecology from Lund University and has since focused on researching the political ecology of the far right, particularly in Germany. She is active in the climate justice movement and is a fellow of the graduate college Socio-Ecological Transformation of the Rosa-Luxemburg-Foundation. Tatjana researches climate obstruction strategies from the far-right to the progressive camp. She also seeks ways to create a future where nature and society are not subjected to capitalist pressures.



## TROY VETTESE

Post-doctoral Fellow, University of California,  
Berkeley, USA

Half- Earth Socialism in Germany

Troy Vettese is a Ciriacy-Wantrup post-doctoral fellow at the University of California, Berkeley. He obtained his PhD from New York University and master's degrees from NYU, St Andrews, and Oxford, and has held research fellowships at the University of Copenhagen, the European University Institute, and Harvard University. Together with Drew Pendergrass, Troy co-authored the manifesto *Half-Earth Socialism* (Verso, 2022), which has been discussed in *Jewish Currents*, *New Statesman*, *Le Monde*, and the *Ecologist*, and has been translated into Swedish, Italian, Thai, Korean, and Spanish. He also helped design a video game based on the book. He is currently writing a monograph on neoliberal environmental thought and editing a volume on Marxist animal studies. Troy's popular writing has appeared in *n+1*, *The Guardian*, *Jacobin*, *Boston Review*, and *Bookforum*.

### **From Market to Planning: A Marxist Perspective**

For this workshop, THE NEW INSTITUTE welcomed three guests to address the question of a legitimacy crisis of neoliberal capitalism and to ask what potentially could come next. Ryuji Sasaki (Rikkyo University, Japan) showed how capitalism and market economy have monopolized social cooperation (commerce, credit systems) in the same way feudalism once monopolized land. As Alyssa Battistoni (Barnard College, USA) further pointed out, according to Marx, both social relations and land are not merely free gifts but rather commons—products of long-term metabolism and human activity that no single person can claim ownership of, but that everyone coordinates. She proposed a model of planning that involves “socializing nature for conscious planet-making.” Utopian as it may seem, Søren Mau (Denmark) argued that Marxists should reassess their critiques of “mere utopian ideas” as inefficient, impossible, or undesirable. If we define utopias as the best possible solutions, they may serve as powerful drivers of material change.

### **Matthias Schmelzer: “Growth, Degrowth and Planning in the Age of Ecological Collapse”**

In this talk, Matthias Schmelzer argued that productivism and the principle of sufficiency can coexist within a vision of a “postgrowth future.” According to Schmelzer, the hegemony of growth has led to an over-fixation on maximizing GDP and optimizing technologies. In contrast, the degrowth perspective seeks to bring political debate back into how we think about the economy and our use of natural and social resources. Schmelzer discussed how we might design institutions that support planning without relying on growth, and how setting limits on resource use could still be compatible with democratic decision-making. He also identified key areas where policies could support this type of planning, and showed how a democratic, socially, and ecologically focused approach could challenge and dismantle misleading narratives that continue to promote growth as the only path forward.

**17.03.25****Degrowth, Planning, Transformation**

This workshop, co-organized by the University of Hamburg's Futures of Sustainability research group and THE NEW INSTITUTE, explored how economic degrowth can be planned and governed in response to the climate crisis. Kohei Saito and Matthias Schmelzer opened the event with reflections on dismantling and restructuring capitalist economies. Further sessions examined macroeconomic and political perspectives on degrowth (Mechthild Schrooten, Christoph Sorg), as well as issues of care and reproduction (Heide Lutosch, with commentary by Christa Wichterich). On the second day, a roundtable featuring Sophie Lampl (Greenpeace) and Mario Candeias (RLS) discussed democratic pathways to transformation. Eva von Redecker, Alex Demirović, and Ulrich Brand introduced the concept of "solidarity-based resilience," followed by a panel on how cities can embody such principles. The workshop emphasized the need for participatory planning and new models of prosperity beyond growth.

**25.03.25****“How Do We Get There? The Socialization of Investment and the Green Transition in Historical and Contemporary Perspective”**

This workshop convened another three guests of THE NEW INSTITUTE to discuss what “transition” and “socialization” are—both conceptually and practically. Daniela Gabor (SOAS, University of London) argued that outsourcing the green transition to private capital is a mistake—markets are neither fast nor fair enough to drive meaningful decarbonization. Instead, she called for using public funds to invest directly in clean industries and for holding private firms accountable when they fall short of climate targets. Neil Warner (LSE) discussed the efforts to socialize investment during the 1970s and 1980s, why these efforts were ultimately unsuccessful, and what lessons they offered for similar programs today. Jacob Blumenfeld (Humboldt University of Berlin) spoke about the 1910s–1920s debates on the concept of “socialization” and the forms it could take.

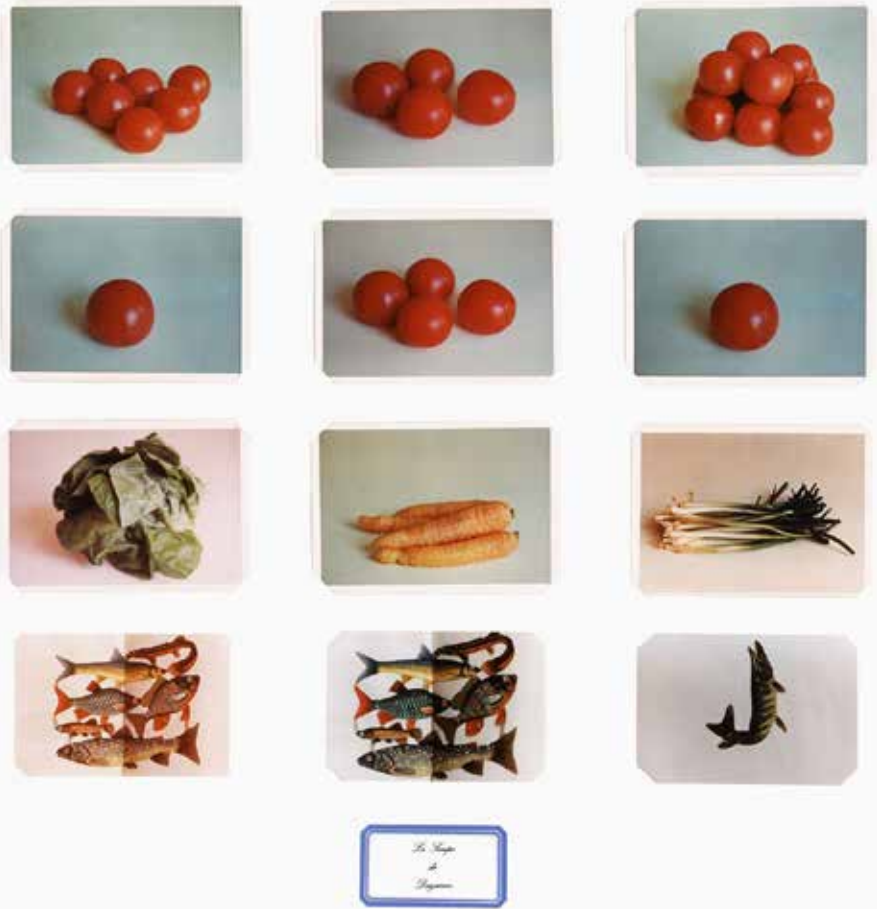

**18.06.25****Drew Pendergrass: “A Curious Natural Selection: János Kornai’s Evolutionary Theory of Socialist Institutions”**

Drew Pendergrass, an environmental scientist affiliated with Harvard University and co-author of *Half-Earth Socialism* (Verso 2022), explored the institutional dynamics of socialist planning through the work of Hungarian economist János Kornai. He contrasted capitalism’s separation of politics and economics—governed by what Marx called capital’s “mute compulsion”—with socialism’s aim to reunite the two under democratic control. Focusing on Kornai’s attempt to use linear programming and computer modelling to improve central planning in 1960s Hungary, Pendergrass described a technically successful effort that nonetheless failed to produce lasting reform. The problem, Kornai argued, was not informational, but structural: socialist institutions had evolved into a self-reinforcing system resistant to change. Pendergrass suggested that Kornai’s account highlights the limits of technocratic fixes and the need for democratic mechanisms that avoid both market domination and top-down control. He concluded by reflecting on the implications for planning and institutional design during ecological crisis.

# The Future of Food: Power and Biodiversity

How can harnessing biodiversity enable progressive power shifts in the food system?

## Introduction

The Future of Food: Power and Biodiversity, a program chaired by José Luis Chicoma, began with pressing questions: what forms of power asymmetries sustain the status quo in global food systems?; who benefits from the way the system is structured?; and who impedes change toward a more equitable, resilient, and socially just food system? Over the course of a year-long interdisciplinary inquiry, fellows Sayed Azam-Ali, Jessica Duncan, María Mideros, Emma McDonell, Nicolás Rovegno, Chris Vogliano, and Kristin Reynolds examined how power shapes food systems at every level—from what is grown and where, to who eats what, who governs this system, and who is excluded from it. They interrogated the structures through which concentrated control over land, markets, institutions, and narratives have produced systems that are ecologically fragile, socially unjust, and politically unbalanced.

What became clear is that global food systems are far more fragile than they appear. Despite often being praised for their scale and productivity, they've shown themselves to be poorly equipped to handle disruption. Climate volatility, geopolitical unrest, conflict, and the erosion of international cooperation have exposed the deeper vulnerabilities of systems designed for efficiency, not equity. These overlapping crises aren't just a string of unfortunate events—they're symptoms of a system that's failing by design.

At the heart of this fragility lies a paradox. Food systems have become more productive and globally integrated than ever before, yet they still fail to deliver affordable, nutritious food to billions of people. A few countries dominate exports, a handful of crops make up most of what we eat, and a small group of multinational corporations controls the key nodes of production—from seeds and fertilizer to processing and distribution. This concentration of power has undermined resilience and narrowed the range of possible reforms, making it harder for alternative food systems to gain traction.

The Future of Food program challenged the idea that these are broken systems in need of technical fixes. Instead, it argued that food systems are working exactly as intended—for those who benefit from the status quo. The program asked what it would take to fundamentally shift power, toward more equitable access to resources, more inclusive governance, and more diverse, locally grounded ways of producing and sharing food.

The research that fellows have conducted will culminate in two major publications by THE NEW INSTITUTE. A policy report titled “The Elephant at the Table: Policy Pathways to Confront Power in Food Systems” will be published in autumn 2025. It offers bold and actionable policy proposals across six core themes: governance and participation, agroecology and seed systems, fisheries and aquaculture, food supply chains, nutrition and diets, and neglected and underutilized species (NUS). Alongside these proposals, the report engages in a rich analysis of power asymmetries in food systems—examining how control over land, markets, governance structures, and knowledge shapes systemic outcomes. The recommendations go beyond incremental reform, offering proposals to reduce corporate concentration and embed justice and ecological sustainability in the governance of food systems.

In 2026, an edited book will follow, expanding on the material developed through the program. Rather than simply diagnosing what is broken, the book examines why food systems continue to fail and who stands to gain from this failure. It offers a novel and comprehensive analysis of power asymmetries across the six core themes of the report, showing how structural power asymmetries have locked food systems into extractive and inequitable patterns.

The work of the program will continue beyond the end of the fellowship. Its findings will be presented at major global forums. Fellows will contribute to public and policy discourse through academic publications, media engagement, and partnerships with civil society organizations, research institutions, and philanthropic foundations.

At a time when multiple crises intersect, The Future of Food program offers a clear and urgent message: food systems are not simply dysfunctional, they are structured in ways that benefit a powerful minority while externalizing harm to people and ecosystems. The program challenges these systems by uncovering the political logic that sustains them and by proposing alternative approaches that prioritize democratic participation, institutional plurality, and the public good. By focusing on power as both the problem and the solution, the program provides a foundation for meaningful and lasting transformation.

Sayed Azam-Ali is the founding CEO of Crops for the Future (CFF), the global center for research on the world's underutilized and forgotten crops. He is also Chair (Emeritus) in Global Food Security at the University of Nottingham. In 2021, he was awarded an OBE for "services to underutilized crops and increasing global food security", and in 2023 was appointed to the High-Level Panel of Experts on Food Security and Nutrition of the UN Committee on World Food Security. Sayed is a past Chair of the Association of International Research and Development Centers for Agriculture and is a regular advisor to the UN Food and Agriculture Organization and the Global Forum on Agricultural Research and Innovation. He holds a BSc degree in Plant Biology from the University of Wales and a PhD in Environmental Physics from the University of Nottingham. He is the author of *The Ninth Revolution: Transforming Food Systems for Good* (2021).

## JESSICA DUNCAN

The Politics of Food Systems Transformation with a Focus on Power, Governance and Future Visions

January–March 2025

Jessica Duncan is a scholar and educator committed to social-ecological justice. She is an Associate Professor in the Politics of Food Systems Transformations at the Rural Sociology Group, Wageningen University. Jessica holds a PhD in Food Policy from City University London (2014). Her research pioneers new ways of understanding and imagining food governance processes to support just and sustainable transformations. Her teaching has been recognized by a number of awards, including Teacher of the Year at Wageningen University (2017). Jessica sits on the Editorial Board for the journal *Sociologia Ruralis* and is a founding member of and ambassador for the Centre for Unusual Collaborations. She is currently chairing the Scientific Committee for the European Society for Rural Sociology (ESRS) and recently served as an expert on the EU Standing Committee for Agricultural Research's 5th Foresight Report on resilience and transformation.

Emma McDonell is a cultural, economic, and environmental anthropologist interested in the applications of ethnographic research to real world problems. She is an Assistant Professor of Anthropology at the University of Tennessee, Chattanooga. Her expertise lies in the intersections of food systems, global markets, sustainable development, and race/racism in Latin America and, in particular, the cultural and economic politics of neglected and under-utilized crops. Emma was a Fulbright Scholar (Peru, 2016) and has taught anthropology at Indiana University, Butler University, and the University of Zürich. Her research has been published in *Gastronomica*, *Agriculture & Human Values*, and the *Latin American Research Review*. Her forthcoming book, *The Quinoa Bust: The Making and Unmaking of an Andean Miracle Crop* (University of California Press) traces the unintended consequences of the quinoa boom and bust in the Peruvian Andes, drawing on 18 months of ethnographic fieldwork in Puno, Peru.

**Hamburg Sustainability Conference: “How to Make Food Systems Better for People and Planet”**

As a prelude to the Hamburg Sustainability Conference 2024, THE NEW INSTITUTE hosted a public event that convened leading researchers and policymakers to explore actionable strategies for transforming food systems in alignment with climate and biodiversity goals. The evening featured presentations by our fellows Jessica Duncan, Sayed Azam-Ali, and Maja Groff, each offering solution-oriented proposals. These presentations were followed by a panel discussion with Achim Steiner (UNDP), José Luis Chicoma, and Martin Frick (World Food Programme), moderated by journalist Conny Czymoch. The discourse centered on elevating the role of food systems in international negotiations and policy frameworks, emphasizing the necessity for integrated approaches that address both human and planetary health. This event underscored the importance of cross-sector collaboration in advancing the Sustainable Development Goals (SDGs) and informed the ongoing work of the program.

## 04–06.03.25 **Advisory Committee Meeting**

THE NEW INSTITUTE hosted an intimate and focused meeting of the Advisory Committee for The Future of Food: Power and Biodiversity. The purpose was to engage a select group of international experts in testing the strategic direction of the program, deepening its proposals for impact, and forming a network for ongoing inspiration and dissemination. Conducted under Chatham House Rules to encourage open and candid exchange, the meeting brought together renowned global experts from the World Food Programme (WFP), United Nations Development Programme (UNDP), World Wide Fund for Nature (WWF), The International Fund for Agricultural Development (IFAD), Biovision Foundation, the Agroecology Coalition, The International Union for Conservation of Nature (IUCN), Slow Food International, CARE, and Bioversity International. Together, participants offered critical insights, evaluated key proposals, and helped refine a transformative agenda grounded in equity, resilience, and biodiversity.

## 23.04.25 **UN Task Force on Food Systems Online Meeting**

José Luis Chicoma participated in a virtual meeting of the UN Task Force on Food Systems, which brought together representatives from key UN agencies working on food and nutrition policy. Chicoma presented on the role of power asymmetries in shaping global food systems, emphasizing how concentrated control over land, markets, and decision-making processes limits the reach of equitable and sustainable reforms.

**17–18.04.25****Perry World House Conference: “Feeding a Climate-Changed World”**

José Luis Chicoma represented THE NEW INSTITUTE at the “Feeding a Climate-Changed World” conference hosted by Perry World House at the University of Pennsylvania. Speaking on the impacts of urbanization and climate change on global diets, he examined how power asymmetries shape nutrition outcomes—highlighting the diversion of nutrient-rich anchoveta into fishmeal, the extraction of superfoods from the Global South, and the marginalization of traditional markets and agroecological practices. Emphasizing that “the world doesn’t need more cheap calories,” Chicoma underscored the urgent need to make healthy food affordable and accessible—especially for those who need it most. He outlined four key policy shifts: redirect subsidies toward agroecology; reform fisheries policy to prioritize local consumption; expand school meal programs that source from smallholder farmers; and invest in traditional markets, which remain critical for delivering diverse, nutritious foods. The conference provided a valuable platform to share the program’s transformative agenda and engage global policymakers in building equitable, climate-resilient food systems.

**28–29.05.25****First International Symposium on Food System Transformation in Mexico**

José Luis Chicoma took part in a landmark gathering on the future of food systems in Mexico, hosted by the Escuela de Gobierno at Tecnológico de Monterrey. In a session on the political economy of food systems, Chicoma offered commentary on how global and local power asymmetries shape the outcomes of food policy, access, and governance. He emphasized the need to center equity, biodiversity, and democratic participation in food system reform—highlighting THE NEW INSTITUTE’s work on nutrition justice, agroecology, and territorial markets. His intervention contributed to broader discussions on reconfiguring food systems through structural, multisectoral change aligned with Mexico’s new legislative framework on sustainable food policy.

**03.06.25****Hamburg Sustainability Conference: “Working with Informality: Food, Livelihoods, and the Path to Resilient Communities”**

THE NEW INSTITUTE co-hosted a compelling public dialogue with TMG Think Tank on the transformative role of informality in building resilient, equitable food systems. Recognizing that 60% of the global workforce participates in informal economies, speakers highlighted how informal food vendors, school meal initiatives, and community-led safety nets are vital levers for food access, decent livelihoods, and climate resilience. The event featured Jes Weigelt (Managing Director, TMG Research), Ann Wanjiru Mbuthia (Coordinator, Mathare Legal Aid & Human Rights Advocacy – MLAHRA), and Nina Wolff (Chair, Slow Food Germany). Future of Food program chair José Luis Chicoma emphasized the need to “work with informality rather than hope it will be eclipsed,” drawing attention to strategies that respect local dynamics and protect food justice. The conversation generated fresh inspiration and fostered a network poised to disseminate insights across policy, research, and grassroots practice.

**23–25.06.25****Wilton Park: “Food Systems and Power: Towards Collective Action for Systemic Change”**

José Luis Chicoma participated in a high-level roundtable on power dynamics in food systems, hosted by Wilton Park in the UK in partnership with UNDP and EIT Food. In a session titled “Understanding Power Dynamics in Food Systems”, Chicoma presented the program’s work on food and power to explore how entrenched power asymmetries—across markets, governance, and knowledge—undermine progress toward equitable, sustainable, and healthy food systems. He contributed to discussions on how global actors shape policy outcomes, distort food environments, and constrain reform. The event brought together policymakers, academics, and civil society leaders to co-develop strategies for addressing hidden and structural power imbalances.

# Planetary Governance

How do we design and implement the needed global governance reforms to address the planetary emergency?

## Introduction

There is an urgent need to implement new approaches, frameworks, and institutions for planetary governance to maintain the viability of our Earth system. The Climate Governance Commission laid out a series of proposals in their flagship report “Governing Our Planetary Emergency” (2023). At THE NEW INSTITUTE, the Planetary Government program focused on the analysis and implementation of a number of these proposals, including:

### **1. A declaration by the UN General Assembly on “planetary emergency”**

Some countries, cities, and institutions have declared a state of emergency in the face of the climate crisis and the overstepping of Planetary Boundaries. But this has not yet happened at the international level, nor has there yet been a high-level recognition of the gravity and scale of the Earth system risks we are facing. One of the main goals of the program at THE NEW INSTITUTE was to further develop the draft content for such a UN General Assembly declaration.

### **2. Establishing an International Environmental Court**

Similar to the International Criminal Court, which has jurisdiction over serious war crimes and crimes against humanity, among others, an International Environmental Court could have jurisdiction over relevant international climate and environmental disputes and, for example, assist in holding states to their promises. But what exactly would the court’s powers be? Which cases would it hear? How would it be funded? “So far, the ideas for an International Environmental Court have been mostly discussed in abstraction,” said program chair Maja Groff. “We worked on establishing the foundations for a process to develop a credible, concrete, and stress-tested proposal.” Groff drew on her experience of developing a model treaty for an International Anti-Corruption Court, which already has the support of many countries and organizations (and was drafted in part at THE NEW INSTITUTE). The foundations for a similar process for an International Environmental Court were laid during the Planetary Governance program at THE NEW INSTITUTE.

### **3. Measures to strengthen the United Nations Environment Programme (UNEP), with the development of a Global Environmental Agency**

“Next-generation” global environmental governance is clearly needed in the face of ever-growing Earth system risks and recognition that all countries will need to work together to address these risks. UNEP has proven a key stakeholder in coordinating these issues, but a strategic upgrade of UNEP into a Global Environment Agency, with stronger coordination powers and an ability to defragment the complex nature of the 100’s of multilateral environmental agreements currently in place could ensure a fit-for-purpose governance body for the Anthropocene. Together with leading experts, the program further refined and workshopped this proposal, identifying opportunities to work toward this next-generation governance.

### **4. Building an Earth Governance Alliance**

The approach followed by the program was to develop thoughtful, high-quality proposals for sound “planetary governance” that lead to real change through the support of “smart coalitions,” i.e., coalitions of global civil society together with like-minded states and other stakeholders. This requires financial resources, critical feedback, and a place where experts, NGOs, think tanks, and government officials can meet face-to-face to build and deepen coalitions and to forge consensus on viable pathways forward, through dialogue and debate. To this end, several meetings with academics, civil society organizations, and lawyers took place at THE NEW INSTITUTE, where projects were discussed, developed, and advanced in numerous workshops. “The Institute acted as a catalyst for our work,” says Groff.

### **International Environmental Court Expert Meeting**

This meeting brought together leading national environmental legal practitioners and international lawyers, including representatives from the ICE Coalition and the Climate Governance Commission (CGC). They discussed the need for an International Court for the Environment and the path forward to establish the Court in the face of current geopolitical and international legal circumstances, while building on the momentum of the International Court of Justice climate case.

**03–07.03.25****Expert Meeting on proposals including a Global Environment Agency (GEA)**

The meeting convened leading Earth system governance experts to further refine key climate governance reform proposals, including the development of a Global Environment Agency, the Establishment of a Planetary Emergency Platform, and the proposal for an international climate policy clearinghouse/hub.

**Expert Meeting on an International Court for the Environment (ICE)****07–08.04.25**

The meeting brought together a wide circle of leading international environmental law experts and legal practitioners, including representatives from the ICE Coalition and the Climate Governance Commission (CGC) to discuss the possible functions and features of an international environmental court, as well as practical next steps. This discussion built on meetings held at THE NEW INSTITUTE in November 2024 and February 2025, which explored initial ideas for such an institution and synergies between the court and other reform proposals by the Commission.

**09.04.25****Youth Expert and Advocate Meeting on Transforming Global Governance for the Planetary Emergency on Wednesday**

The meeting brought leaders from the youth movement together with the Climate Governance Commission (CGC) and supporting partners at Mobilizing an Earth Governance Alliance (MEGA) to strategize on integrating youth perspectives in driving climate action. The goal is to build on the prior success of the youth movement (as with the International Court of Justice Advisory Opinion on climate and multiple youth-led climate national litigation efforts) and identify areas to work together on implementing priority proposals.

**11.04.25****Private Sector Expert Meeting on Transforming Global Governance for the Planetary Emergency**

The meeting brought together leaders from the progressive business movement with the Climate Governance Commission (CGC) and supporting partners at Mobilizing an Earth Governance Alliance (MEGA) to discuss and refine the prioritized governance proposals with a specific focus on integrating private sector perspectives.

---

**01.06.25****Hamburg Sustainability Conference Pre-Event**

The pre-event began with an expert roundtable co-hosted by leading scientist David Obura, Chair of the Intergovernmental Science-Policy Platform on Biodiversity and Ecosystem Services (IPBES), on the economic transformations necessary to address Earth system risks. The roundtable, which included private sector leaders, academics, and policymakers, involved a rich discussion of the importance of transforming financial and economic paradigms to ensure the recognition and restoration of natural capital, as well as some of the practical steps that could be taken to drive this transformation. Participants from a variety of expert backgrounds were able to synergistically identify potential areas for collaboration.



Following this was a closed-door workshop which included the Climate Governance Commission, THE NEW INSTITUTE's Planetary Governance Program, and international leading scientists and global governance experts and policymakers to discuss next steps for the developments of policy and governance solutions to sufficiently monitor and respond to Earth system destabilizations and risks.

In the evening, a public panel discussion and Q&A on the science and the various solutions, e.g., the enhancement of international Earth system monitoring capacity, a declaration of the UN General Assembly on novel Earth system risks, the convening of a Planetary Emergency Platform, and the establishment of a Global Climate and Nature Policy Innovation Hub, took place at THE NEW INSTITUTE.

---

## 04–05.06.25 **Climate Governance Commission Meeting**

Building on the bilateral conversations which have taken place in the Commission and with external partners since September 2023, the aim of the meeting was to chart the Commission's path forward. Specifically, the meeting focused on the following objectives:

1. To formally update the Commission on ongoing work, achievements, and consider plans for the future implementation phase of the Commission, highlighting our rapidly accelerating progress with building high-level partnerships and support for a number of key proposals, and identifying how the Commissioners can continue to support this work.
2. To consider our response to current trends in international affairs, building on suggestions from Commissioners/Co-Chairs.
3. To receive Commissioner input on a planned 10–15 page update to our 2023 Report.
4. To discuss the future configuration of the Commission.

The Commissioners also had an opportunity to directly engage with members of the Brazil COP30 team and identify synergies between the Commission's proposals and the COP team's proposals regarding efforts to enhance multilateral governance.

### **New Leadership for Earth System Governance: Ensuring Human Flourishing in the Anthropocene**

This event engaged leading women protagonists in international law, policy, diplomacy, and politics, in a dialogue about our international predicaments and pathways out of current crises.

Moderated by THE NEW INSTITUTE Program Chair Maja Groff, panel participants included: Maria Fernanda Espinosa (Co-Chair CGC, President of the 73rd UN General Assembly, Former Ministerial roles, Ecuador, Executive Director Global Women Leaders), Thilmeeza Hussain (Commissioner, Former Permanent Representative of The Maldives to the United Nations, Director, UN Regional Commissions New York Office), and Sandrine Dixon-Declève (Commissioner, Executive Chair, Earth4All, Former Co-President, Club of Rome).

The event considered practical yet ambitious ideas to improve global climate and ecological governance, drawing attention to the need to reform major institutions, instruments, policies, laws, rules, norms, and coordination processes among different actors to better respond to the threat of the triple planetary crisis of biodiversity loss, pollution, and climate change. There was a particular focus on the need to remain within Planetary Boundaries and avoid crossing critical Earth system tipping points. The panel established broad areas of consensus on priority global governance reform innovations, building on the landmark 2023 report by the Climate Governance Commission “Governing Our Planetary Emergency” (2023). It shared perspectives on the growing global support and diverse, powerful networks of organizations and individuals committed to growing a coalition of states and non-state actors to achieve critical global governance changes within the next one-to-three years (for near-term innovations) and three-to-five years (for medium-term “next-generation” innovations).

# Futures of Capitalism: Radical Democracy and The Financial Imagination

How do the workings of financial markets shape our social reality, and how can practices of speculation and distortion become tools of radical democratic imagination?

## Introduction

Finance developed within capitalism as a practical tool for managing risk. Futures trading emerged at the Chicago Board of Trade in the 19th century, allowing farmers and merchants to hedge against price volatility. Futures contracts helped turn uncertainty into something tradable and manageable—an innovation that reflects finance’s foundational role in stabilizing markets and supporting economic activity.

But over time, finance’s role evolved. Its future-making technologies—speculation, forecasting, gambling—began not just to manage risk, but to actively shape our lived realities. What started as a system to mitigate uncertainty gradually became a powerful force that constructs the future itself. As the logic of risk intensified, so did the logic of reward. The higher the risk, the higher the potential gain—and the more pronounced the economic agency—until economic behavior itself was redefined. “Homo economicus”, once a rational actor focused on efficiency and risk management, gave way to “homo speculans”, a being driven by speculation, with uncertainty not only as a challenge to overcome, but as an opportunity to exploit—even when speculating on its own survival.

That disturbing observation alone—how risk became an asset rather than a side-effect and how “homo economicus” had evolved into “homo speculans”—marked a striking twist in the history and anthropology of finance. It was an observation well worth deeper exploration, and the Futures of Capitalism program, led by Aris Komporozos-Athanasίου, pushed the discourse even further.

As a sociologist of finance, Komporozos-Athanasίου argued that finance was not merely a market tool. Rather, it has the power to create entire worlds—worlds in which assets can shift from being stabilizing forces to sources of volatility. Finance, in his view, is also a way that actors imagine and engage with their possible futures. To participate in finance is, in this case, an existential act: a way of claiming, individually or collectively, the uncertainty of what lies ahead.

During the Autumn Term of the academic year 2024–2025, in addition to Aris Komporozos-Athanasiou, the group included anthropologist Kimberly Chong and was often joined online by historian Jamie Pietruska and sociologist Melinda Cooper who joined the program in person at THE NEW INSTITUTE later in the academic year.

The program focused on developing a “speculation spectrum” as its main heuristic outcome. This “spectrum” viewed various financial phenomena as those of a dual nature, “flipping” between stability and volatility depending on context and cultural embeddedness. Is contributing to a pension really a safe investment and buying crypto a risky one? The answer, the fellows argued, was no: both can be either safe or risky.

As one pulls a dot—representing an established form of financial activity, such as investing in pensions—along the spectrum, one uncovers hidden sub-worlds within each. These variations are not only about material outcomes like gains or losses, but also about symbolic meaning. The more speculative an investment was, the more it could serve as a source of resilience and empowerment, especially for communities historically marginalized by mainstream financial systems. The question then arose: what was the proper way to translate these sentiments into the spectrum? On that point, Komporozos-Athanasiou worked closely with another Futures of Capitalism fellow, Till Wittwer, an artist and researcher of how “reality” is constructed. In the Winter Term, Jamie Pietruska, Till Wittwer, and a researcher of long-termism, Giulia Dal Maso, came to THE NEW INSTITUTE. By March 2025, the logics of the speculation spectrum was further refined and each fellow started working on a concrete financial mechanism —pensions, catastrophe bonds, asset management, financial tackling of long-termism —to showcase how the spectrum works.

As the work advanced, Komporozos-Athanasiou saw a way to push the discussion even further beyond a mere “worlding of finance” to explore its spill-over effects—how it impacts areas outside of its immediate domain and interacts with various crises—demographic, climate, geopolitical, and democratic. He framed it within the concept of Collapse Finance. Crucial to this framework was the idea that not only does finance notoriously profit from various systemic collapses, but it is also transformed by them in ways that can give rise to radically new financial imaginations—precisely because, as the program pointed out at the beginning, the world of finance is generative by nature.

In the Spring Term, Komporozos-Athanasiou worked with Cooper, Dal Maso, and Wittwer to test the Collapse Finance framework. In June, the Futures of Capitalism program brought together scholars, journalists, and activists at THE NEW INSTITUTE for an experimental end-of-year conversation. Curated and designed by Till Wittwer, the event featured a Collapse Finance booklet with content by Komporozos-Athanasiou, Dal Maso, and Wittwer. It also marked the launch of the Global Consortium for Rethinking Capitalism (GCRC), which will continue beyond the 2024–2025 academic year, based at the Center for Capitalism Studies at University College London. The GCRC aims to reimagine how we study markets and financial systems through global collaboration. A Collapse Finance film is currently in production and set for release in late 2025.

## ARIS KOMPOROZOS - ATHANASIOU

Associate Professor of Sociology, University College London, United Kingdom

Aris Komporozos-Athanasiou is an Associate Professor of Sociology at University College London and Director of the UCL Centre for Capitalism Studies. He is the author of *Speculative Communities: Living with Uncertainty in a Financialized World* (University of Chicago Press, 2022) and *Real Fake*, which will be published by MIT Press in 2026. Aris's research traces the multifaceted impact of financial markets on everyday life and on our political imagination. His widely acclaimed theory of capitalism has developed a critical vision that connects speculation, politics, and progressive futurity in the struggle for financial justice and social solidarity. His work has been featured in *The New Yorker*, *Bookforum*, and the Locarno Film Festival, and his public writing has appeared in *The Guardian*, *Aeon*, *The Boston Review*, *Los Angeles Review of Books*, and other publications.



## KIMBERLY CHONG

Associate Professor in the Department of Anthropology, University College London, UK

Cosmologies of Value, Inequality and the Financial Imagination

September 2024–June 2025

Kimberly Chong is an Associate Professor in the Department of Anthropology at University College London. Her research explores the production of financialized capitalism through expert practices, drawing on fieldwork with management consultants, fund managers, and back-office knowledge workers. While Kimberly's first research project focused on the commensuration of moral and economic value in the legitimation of the financialization of work, her current research considers how inequality and social difference are drawn upon and produced through practices of speculation and valuation. She draws inspiration from feminist anthropology, studies of racial capitalism, and the anthropology of finance. Kimberly's first book, *Best Practice: Management Consulting and the Ethics of Financialization in China*, won the 2021 European Group for Organizational Studies Book Award.



## MELINDA COOPER

School of Sociology, Research School of Social Sciences, Australian National University, Australia

Founder Fantasies: Private Investment Funds and the Silicon Valley Far Right

May–June 2024

Melinda Cooper is a social and political theorist who earned her Diplôme d'Etudes Approfondies (DEA) and Doctorate at the University of Paris VIII (Vincennes-a-St-Denis). Her most recent monograph, *Counterrevolution: Extravagance and Austerity in Public Finance* (2024), seeks to understand the countervailing influences that push governments towards permanent public spending austerity while at the same time allowing for a proliferation of monetary and fiscal backstops to private wealth. She is currently based in the School of Sociology at the Australian National University where she teaches classical social theory, feminist theory, Australian neoliberalism, and theories of populism.



## GIULIA DAL MASO

Research Fellow at Ca' Foscari University of Venice, Italy and at the National University of Singapore

Longevity Finance: The speculative search for life extension

January–March 2025

Giulia Dal Maso is a Marie Skłodowska-Curie Fellow at both the Ca' Foscari University of Venice and the Asia Research Institute at the National University of Singapore. Her research focuses on the impact of financial markets on social and political spheres. Giulia has worked extensively on the rise of financialization in post-socialist contexts, with a particular focus on China and Eastern Europe. She has also studied the development of green and sustainable finance in Chinese and broader Asian contexts. Her work has appeared in publications such as *Jacobin*, the *Journal of Cultural Economy*, *South Atlantic Quarterly*, *Historical Materialism*, *Social and Cultural Geography*, and *Focaal*.



## JAMIE PIETRUSKA

Associate Professor of History, Rutgers University, USA

Weather Gambling from the Gilded Age to Climate Crisis and a Primer on Capitalist Futures

January–March 2025

Jamie Pietruska is Associate Professor of History at Rutgers University. Her research focuses on technoscience and the production of knowledge in economic life. Her books, articles, and essays have explored a range of topics, including the regulation of fake weather forecasts, the long history of information economies, and imperial meteorological infrastructures. Current projects include a history of weather gambling and its relationship to finance capitalism, and a history of inquiry that explores the historical tension between data imaginaries and data practices. Jamie's work has been featured in the *Washington Post*, on NPR, and on various podcasts. She received her PhD from the Program in History, Anthropology, and STS at the Massachusetts Institute of Technology and has held postdoctoral fellowships from the American Academy of Arts and Sciences and the American Council of Learned Societies.



## JAMIESON WEBSTER

Psychoanalyst, New York, USA

Subjectivities, Symptoms and Solutions under Late Capitalism: A Clinical Psychoanalyst's Perspective

May–June 2025

Jamieson Webster is a psychoanalyst in private practice in New York City and a part-time faculty member at The New School for Social Research. She is the author, most recently, of *On Breathing* (Peninsula Press, UK; Catapult, US), as well as *Conversion Disorder: Listening to the Body in Psychoanalysis* (Columbia, 2018) and, with Simon Critchley, *Stay, Illusion! The Hamlet Doctrine* (Vintage Random House, 2013). She has written regularly for *Artforum*, *The New York Times*, and *The New York Review of Books*, as well as many psychoanalytic publications.



## TILL WITTWER

Artist, Writer, and Researcher, Berlin, Germany

Building Fiction (Versuch II)

January–March 2025

Till Wittwer is an artist, writer, and researcher. He creates research-based narratives exploring the ways in which “reality” is constructed. These narratives come in the form of lectures, performances, essays, publications, video, and – occasionally – games. After obtaining degrees in Theater Studies at the Free University of Berlin (FU) and Fine Arts at the University of the Arts Berlin (UdK), Till became a Research Scholar at the School of the Art Institute of Chicago (SAIC) where he made his first attempt to grapple with the evasiveness of finance, researching Louis Sullivan’s lost Chicago Stock Exchange building and the current Chicago Board Options Exchange. This resulted in the 2-channel film “Building Fiction (Versuch I).” His work has been shown internationally, including at Kunstverein Hannover, Re:Publica, Filmfront Chicago, KOW Gallery, and the Hammer Museum Los Angeles. His writings have been widely published, he has taught at art schools and universities, and his catalogue *Fabrikanten der Wirklichkeit* was recently published by Kunstverein Hannover.



Director, Max Planck Institute for the Study of Societies, Cologne, Germany

Visitor, May–June 2025

Jens Beckert is Director of the Max Planck Institute for the Study of Societies (Max Planck Institut für Gesellschaftsforschung) and Professor of Sociology at the University of Cologne. He has previously taught in Göttingen, New York, Princeton, Paris, and at Harvard University. He was awarded the Berlin-Brandenburg Academy of Sciences and Humanities Prize in 2005 and the Leibniz Prize of the German Research Foundation in 2018. Jens received the Karl Polanyi Prize from the German Sociological Association for his book *Imaginierte Zukunft. Fiktionale Erwartungen und kapitalistische Dynamik*.

### Will Capitalism Survive the 21st Century?

The inaugural conversation hosted by the UCL Centre for Capitalism Studies (CCS), led by Aris Komporozos-Athanasiou, examined critical challenges facing capitalism amid growing inequality and ecological crisis. Facilitated with support from THE NEW INSTITUTE, the event convened economist Thomas Piketty, political commentator Ash Sarkar, and anthropologist and journalist Gillian Tett for a rigorous debate.

Piketty offered a cautiously optimistic outlook, advocating a global wealth tax and emphasizing the state's historic capacity to respond to systemic crises. Sarkar countered with skepticism, questioning the feasibility of coordinated global action amid resurgent nationalism and capitalism's moral erosion. Tett provided a historical perspective, tracing neoliberalism's decline to its neglect of market morality and highlighting the rise of cultural conservatism.

### **Kristian Bondo Hansen: “Scaling AI with fake data: The Promises and Pitfalls of Synthetic Data in Finance and Beyond”**

By the time of this talk, Kristian Bondo Hansen from Copenhagen Business School had already been involved in the program’s work for some time through online meetings. Together with the fellows, he explored how synthetic data reshapes risk perception and normalizes uncertainty as a default condition of our world—albeit one that remains manageable. In this talk to the wider community of THE NEW INSTITUTE, Bondo Hansen focused on the question of “what is synthetic data?”

Synthetic data replicates the statistical properties of real data and looks identical to it. It originated in urban studies, where researchers modeled population shifts between neighborhoods in artificially closed environments. Unlike real data, synthetic data is free of noise, making it easier to process with AI. In this sense, it is a case of technology enabling technology in the pursuit of experimental purity.

But how is such data valued, evaluated, and governed? Through this question, Bondo Hansen highlighted both the transformative potential and the ethical and technical challenges of relying on artificial datasets to shape AI-driven futures.

**12.02.25****Max Haiven: “The Gamed Economy and Its Discontents”**

In this public lecture at THE NEW INSTITUTE, Max Haiven explored how economic life has become increasingly shaped by the logic of games—where risk, reward, and strategic behavior dominate not only financial markets but also everyday life. Drawing on his work in cultural theory and political economy, Haiven examined the consequences of a world in which finance, speculation, and algorithmic control turn workers, citizens, and consumers into players navigating rigged systems. He argued that this “gamed economy” fosters cynicism, competition, and a breakdown of solidarity, while obscuring the power structures behind inequality and ecological crisis. Haiven also reflected on the possibilities for resistance and imagination beyond the game, urging a politics rooted in collective care and creativity.

**12–16.05.25****Xin Liu at THE NEW INSTITUTE**

In May 2025, Xin Liu, a research fellow from the Turku Institute of Advanced Studies (TIAS), visited THE NEW INSTITUTE as a guest of the Futures of Capitalism program. During her visit, she engaged in focused discussions with Aris Komporozos-Athanasios and Melinda Cooper on the role of lotteries in China—drawing from her research on *The Lottery Nation*—and exchanged ideas on program developments. Her contributions sparked fresh insights into how speculative culture and institutional innovation intersect in financial systems. The visit strengthened ties between TIAS and the Futures of Capitalism initiative and laid the groundwork for collaborative research moving forward. present generation has a responsibility to ensure that future generations have the capacity to meet their basic needs, including access to drinkable water, food, and healthcare.

**22.05.25****Jens Beckert: “Valuation, Capitalism, and Imaginaries of the Future”**

In his in-depth conversation with Aris Komporozos-Athanasiou and Melinda Cooper at THE NEW INSTITUTE, Jens Beckert reflected on the limits of imagined futures when confronting climate collapse. Beckert asked: what are the structural barriers within capitalist modernity that hinder meaningful action? He explored why societies fail to act despite clear climate knowledge, suggesting that loss—not hope—dominates collective outlooks. Class-based organization is broken, and populists have absorbed peoples’ grievances. Markets, Beckert argued, are essential for organizing complexity but inadequate for confronting externalities. While he doubted the feasibility of post-growth capitalism, he called for fresh thinking around redistribution, valuation, and political will in navigating the transition to sustainable futures. His point of hope was the idea that perhaps progressive imaginaries could emerge amid stagnation and inequality.

**10–11.06.25****“Collapse Finance”, the inaugural workshop of the Global Consortium for Rethinking Capitalism (GCRC)**

At THE NEW INSTITUTE, the Collapse Finance workshop—a major international convention—brought together high impact participants to ask: what happens to finance in a collapsing world? Sessions traced how markets run on imagined futures—fictional expectations shaped by power, not care. Climate risk gets priced but rarely prevented. AI systems, seen as objective, often deepen inequality. They classify, exclude, and obscure. Finance also reshapes politics—turning public needs into private risk. Even life itself is financialized, turned into speculative capital. A new figure emerged: no longer “homo economicus” but “homo speculans”—a person who navigates crisis from below, betting on unstable futures. Participants questioned whether grassroots finance—mutual aid, crypto, informal economies—can break free from the system’s grip. Or does it just mimic its logic? Rather than close off possibilities, collapse became a lens. A moment to rethink value, risk, and solidarity. Not to fix finance—but to ask what comes next.

**11.06.25****Gillian Tett: “The Future of Finance: The Three “Ds” Reshaping Money”**

In the keynote closing the Collapse Finance workshop, the former Chair of the FT Editorial Board and co-founder of Moral Money, Gillian Tett explored how deregulation, de-dollarization, and digitalization are radically reshaping global finance. Framing this transformation as an inflection point, she examined not just economic trends but deeper cultural and institutional shifts in the meaning and function of money. Tett also reflected on the etymology of such terms as “finance” and “company”, reminding us that these concepts originated in ideas of mutual obligation and shared purpose. Drawing on her anthropological background, she offered insights into the secular structure of trust in Japan, where informal mechanisms are often substituted for formal regulation—until each crisis erodes them further. These reflections underscored how trust in financial systems is historically contingent and structurally fragile. Ultimately, the keynote called for rethinking finance not just as a technical system, but as a social and political project, shaped by collective beliefs and vulnerable to collapse—yet also open to reinvention.

**“On Breathing and Collapse: Book Discussion with Aris Komporozos-Athanasiou and Jamieson Webster”**

This public conversation at THE NEW INSTITUTE featured Aris Komporozos-Athanasiou and psychoanalyst Jamieson Webster discussing her recent book *On Breathing*. Framing the discussion were themes of collapse—ecological, social, and psychic—and the ways in which breath figures as both a physical act and a political metaphor. Webster reflected on how breath becomes regulated, pathologized, or reclaimed in times of crisis, while Komporozos-Athanasiou brought in insights from his forthcoming book *Real Fake* to explore how fantasy and disorganization shape collective responses to breakdown. Together, they considered how breathing opens a space for refusal, affective resistance, and alternative forms of relationality under neoliberal collapse.

# Bitter Victory

Is Victory Possible in the 21st Century?

## Introduction

Terror, violence, and wars persist relentlessly, affecting every corner of our planet. Civil and civic, socio-political, economic, scientific, and cultural discourses are contaminated by the pervasive presence of militant rhetoric and warrior-like language. In the Bitter Victory program, the fellows dissected and compared the evolution of victory doctrines and explored their implications on the termination of violence and establishment of peace.

Democracy legitimizes itself by recognizing and respecting those fairly defeated in elections, in the fair exchange of ideas, and the fair competition of market economies. However, there is a growing public perception of political opponents as “absolute enemies” who must be defeated at all costs, posing a threat to democracy. The program’s critical analysis of “winning at all costs” was not just a scholarly pursuit but a crucial step towards defending the integrity of Western democracies by reconstructing its principles of victory, understanding future global conflicts, and promoting peace.

The analysis of the meaning of “victory” also extends beyond democratic societies to include armed groups and states that lack a democratic tradition. Here the focus of the Bitter Victory program was on redefining the principle of “victory” within the strategies and ethics of warfare of these non-democratic entities as they engage in warfare or develop geostrategic ambitions. Understanding their perspective on victory is a theoretical exercise and a necessary step towards comprehensively understanding future global conflicts. In the near future, in addition to Russia and Israel, China will also become a central topic in discussions about winning and victory.

Between 2013 and 2022, he taught at the Moscow School of Social and Economic Sciences (Shaninka) and at HSE University, where he was deputy dean for research at the Faculty of Humanities and associate professor. Arseniy has authored numerous articles in Russian and English, as well as three books in Russian, and is the editor of the book series of the New Literary Observer (NLO) publishing house. ### **Panel Discussion: What Kind of Victory is Possible in the 21st Century?**

In the modern era, neither superpowers nor insurgent groups seem capable of securing decisive victories. Battlefield triumphs turn into endless conflicts, leaving wars that outlast generations. THE NEW INSTITUTE fellow Sanja Bojanić moderated a lively discussion around the questions “how can wars in the 21st century truly end?”, “what defines military success, and “what does claiming victory in modern warfare mean?”

The panel discussion explored the evolving concept of victory and the different dimensions of winning, ending a conflict, and obtaining peace and security.

Panelists were Beatrice Heuser (University of Glasgow), Argyro Kartsonaki and Cornelius Friesendorf (both from the Institute for Peace Research and Security Policy, University of Hamburg), and Maja Groff (THE NEW INSTITUTE).

Fritz Breithaupt is a Professor of Germanic Studies and Cognitive Science at Indiana University, where he became one of the youngest to receive the title of Provost Professor in 2017. He earned his PhD in German literature from Johns Hopkins University and has been a Fulbright and Alexander von Humboldt Fellow, as well as a Visiting Professor at St. Gallen University. At Indiana, he leads the Experimental Humanities Lab, bridging the sciences and humanities, and develops courses in cognitive arts. She has held senior roles at UN international criminal tribunals, including Senior Judicial Coordinator at the Extraordinary Chambers in the Courts of Cambodia, Chef de Cabinet at the International Criminal Tribunal for Rwanda, and Appeals Counsel at the International Criminal Tribunal for Yugoslavia. She holds degrees from Otago University in law and international relations, and undertook doctoral studies at Oxford University focused on the scope of the UN Security Council's enforcement powers.



## MARTIN MULSOW

Professor of Intellectual History, University of Erfurt, Germany

Wahrheit: Eine Tiefengeschichte

September 2024–June 2025

Martin Mulsow is a Professor of Intellectual History at the University of Erfurt and Director of the Gotha Research Center. He studied philosophy in Tübingen, Berlin, and Munich. From 2005 to 2008 he was Professor of History at Rutgers University, USA. He is a member of several German academies and has been a member of the Institute for Advanced Study in Princeton, the Wissenschaftskolleg in Berlin, and the NIAS in Amsterdam. His work on Renaissance philosophy, the history of early modern science, and the Radical Enlightenment has received numerous awards, including the Berlin-Brandenburg Academy of Sciences and Humanities Prize and the Anna Krüger Prize. Martin is interested in painting, traveling, and foreign cultures. He is currently working on a deep history of truth and on how intellectual history (and especially the history of the Enlightenment) is affected by the climate crisis.



## BERNHARD PÖRKSEN

Professor of Media Studies, University of Tübingen, Germany

Taking the Long View in Journalism: How to Make Information Matter

September 2024–March 2025

Bernhard Pörksen is a Professor of Media Studies at the University of Tübingen. His research focuses on the mechanisms, dynamics, and conflicts of media communication and public discourse. Bernhard has written or co-authored books on topics such as communication theory, journalism education, cybernetics, systemic thinking, and constructivist epistemology. His current research projects and areas of interest are: the dynamics of outrage in the digital age – developing a framework to study how scandals are reshaped in a networked world; 2) media literacy for the digital age –linking the principles of quality journalism to a practical ethics of communication for a future “editorial society”; and 3) public conflict dynamics – applying communication psychology to de-escalate discourse across social levels.



## FELIX ROHRBECK

Felix Rohrbeck is a graduate economist and communications expert. As a business journalist, he has received many awards for his investigative research, elaborate reporting, and cross-media stories. Between 2014 and 2019, he edited the economics desk at DIE ZEIT, the largest weekly newspaper in Germany. In this capacity he was involved in exposing the “cum-ex” scandal, the biggest tax robbery in Europe. In 2020 Felix co-founded the media-startup Flip. He was a Thomas Mann House Fellow in 2023.



## FRANCISCO SAGASTI

Francisco Sagasti is a professor at the Pacifico Business School in Lima, Peru, and a senior affiliated researcher at the Instituto de Estudios Peruanos. He has served as President of Peru, a congressman, head of his parliamentary caucus, and chairman of the Science and Technology Committee. Previously, he was a fellow at the Wilson Center, executive director of FORO Nacional Internacional, chief of strategic planning at the World Bank, and chairman of the United Nations Advisory Committee on Science and Technology. He has been a visiting professor at the Wharton School, the Instituto de Empresa, and the University for Peace, and a consultant to numerous international organizations. Founder and former Executive Director of GRADE, a leading Peruvian think tank, Francisco has published extensively, with over 200 articles and 30 books. His awards include the Paul Hoffmann Prize, the Robert K. Merton Prize, and the Edgardo Habich Prize.



## MINNA SALAMI

Writer, Journalist, Speaker

November 2022–June 2025

Minna Salami is a Nigerian-Finnish-Swedish feminist author and social critic whose work delves into the politics of knowledge production, the progression of feminist theory, and contemporary African thought. Her acclaimed debut, *Sensuous Knowledge* (2020), has been translated into several languages, and her new book, *Can Feminism Be African?* (HarperCollins, 2025), has just been published. She is the founder of the award-winning blog *MsAfropolitan* and a frequent speaker at institutions such as the UN, Oxford, Cambridge, Yale, and NASA's Singularity University. Minna is a Full Member of the Club of Rome, a BMW Foundation Responsible Leader, and serves on several boards, including The Royal Institute of Philosophy and The African Feminist Initiative at Penn State. She has also advised governments on race and gender equality and curated events at London's V&A Museum.

The Fellowship is tied to financial support up to 50,000 Euros for individual projects that aim to preserve free scientific exchange. ## Academic Year 2024-25

JOANNA KAROLINA MALINOWSKA

Assistant Professor, Adam Mickiewicz University, Poznań, Poland

Frontline Voices: Complex Pathways of Racialization at the Polish-Belarusian Border and Their Impact on the Development of Health Inequities

January–June 2025

Joanna Karolina Malinowska is an Assistant Professor at the Faculty of Philosophy, Adam Mickiewicz University in Poznań, Poland. Her work lies at the intersection of philosophy of science, ontology, epistemology, and ethics, with a focus on how concepts such as race and ethnicity are understood in scientific contexts. From 2021 to 2024, she led a project on the use of ethnoracial categories in biomedical research and health care, funded by the Polish National Science Centre. Since 2024, she has been part of a research group studying contemporary approaches to human remains, supported by the Constructive Advanced Thinking program of NetIAS. Joanna is currently working on the issue of conceptualizing whiteness in research on health inequities, particularly in relation to racialization of Eastern Europeans and among Central and Eastern European communities.



**Project: Frontline Voices: Complex Pathways of Racialization at the Polish-Belarusian Border and Their Impact on the Development of Health Inequities**

The project investigates the health consequences of racialized border governance at the Polish-Belarusian frontier—one of the most politically charged and under-documented regions of the European Union. It aims to examine how intersecting processes of racialization, militarization, and institutional neglect affect both people on the move (migrants from various racialized groups) and residents (activists, healthcare professionals etc.) in Poland's eastern periphery.

By adopting an ecosocial perspective on health—as shaped not only by biological, but also by environmental, social and structural factors—the project builds on recent advances in epidemiology, critical public health, bioethics, and border studies. It adjusts frameworks constructed for analyzing racism as a social/structural determinant of health in the US context to the complex ethnoracial relations and hierarchies in Europe (with particular emphasis on Central and Eastern Europe). The project also contributes to contemporary debates on epistemic injustice, documenting how certain forms of ethnoracial discrimination and suffering are rendered invisible, illegible, or systematically ignored in national and EU-level discourse.

The project's primary output will be a feature-length documentary film, produced in close collaboration with activists, medical workers, and residents. The film will be structured around first-person testimonies and on-site documentation, and will prioritize reliability and dignity. The project's impact will extend beyond traditional research outputs—reaching broader audiences through film, preserving fragile testimonies, and enabling transnational dialogue around racialized violence, health, and care.

The project is designed to produce meaningful outcomes across three dimensions: public engagement, academic contribution, and long-term documentation. First, it advances theoretical frameworks for understanding racism and health beyond traditional U.S.-centric models. While much global health research continues to conceptualize racism primarily through a binary opposition between people racialized as white and non-white, this project foregrounds a more nuanced and transnational approach, analyzing how processes of racialization operate through geopolitical marginality, legal status, religion and class, and other intersecting factors. Second, it reclaims critical knowledge production under conditions of repression. In a political context where academic freedom is increasingly constrained,

the project demonstrates that situated, community-accountable research is not only possible but necessary. Its methodology—combining testimonial research, participatory ethics, and visual counter-narratives—challenges both the epistemic silencing of humanitarian crises and the depoliticization of racial health inequities.

The project aligns closely with the founding principles of the Yehudi and Yehuda Elkana Fellowship: to support scholars who take risks in politically repressive environments, challenge conventional thinking, and pursue uncomfortable truths. It will leave a concrete legacy of ethical intervention and public truth-telling.

## Academic Year 2023-24

ESENGÜL AYYILDIZ

Co-Founder Aramızda Association for Gender Research

September 2023–March 2024

Esengül Ayyıldız is the co-founder of the Aramızda Association for Gender Research, a solidarity academy founded by female scholars to advance gender studies and equality. Her work also explores memory politics and cultural production related to state violence. In 2020, she coordinated the project Dersim 1937–38: Mapping the Sites of Massacres and Mass Graves in Turkey, supported by the Friedrich-Ebert-Foundation. In 2017, Esengül, like many of her colleagues, fell victim to an emergency decree that banned her from state employment because she signed the peace petition against inhumane violence conducted by the Turkish State in the Kurdish region. After nearly seven years, she got her academic position back and is continuing her academic work as Assistant Professor at the Faculty of Communication in Çukurova University.



**Project: Global Authoritarianism and Anti-Gender Politics in Europe**

ARAMIZDA (In Between) Association for Gender Research was founded in 2017. Its headquarters is in Ankara. It has 83 members living in different provinces of Turkey. The members consist of academics, researchers, and graduate students working on gender studies and queer studies who have been suspended from universities as a result of political pressure and unlawful interventions. In 2019, due to the current political climate in Turkey, the field of gender studies came under pressure and gender courses were closed in many universities and centers.

In this authoritarian climate, the founding aim of the association is to open a feminist space in the field of gender studies outside the academy, but with an intersectional network in academic production, civil society, politics, and art. It shares the knowledge it has gained in the field of gender studies with civil society organizations and initiatives that struggle in this field, by publishing reports, interviews, and podcast series, and participates in various local and national networks.

One of the current projects is “Defending, Making Visible, Empowering Gender Studies in Academia”. To combat anti-gender attitudes, it creates mechanisms to empower researchers, academics, and students. It also aims to build a network to bring researchers or students working in universities and NGOs together, to provide the necessary collaborations and to form working groups to focus on specific problem areas.

## FERENC HAMMER

Associate Professor, Department of Media and Communication, Eötvös Lóránd University, Budapest, Hungary

September 2023–March 2024

Ferenc Hammer currently was on a sabbatical leave from his position at ELTE Eötvös Loránd University in Budapest. His present research and policy initiative is dedicated to addressing certain dimensions of silencing, self-censorship, and intimidation in academia. This approach involves implementing a mentoring system designed for scholars at risk. A crucial objective of this initiative is to introduce and implement an information technology-based communication system into the academic publication process. This system aims to protect scholars facing risks in their academic pursuits.

**Project: Mesh – A Distance Support Scheme for Scholars at Risk**

With the help of his Elkana budget, Ferenc Hammer founded MESH – Academia without borders, an initiative dedicated to supporting academics who face restrictions on their research, teaching, and expression while remaining in their home countries. MESH aims to create meaningful connections across borders to ensure that no scholar must work in isolation. It aims to do so by providing secure mentoring networks where at-risk scholars connect with international academic partners through secure communication channels. MESH is also working on an anonymous publishing system, where scholars at risk can publish their work internationally without the risk of retaliation in their home countries. MESH's blockchain-based publishing system allows these scholars to anonymously submit their work for peer review and publication, without revealing their identities. This protects them from potential consequences.



## Academic Year 2022-23

IRYNA KASHTALIAN

Scientific Researcher, Buchenwald Memorial  
Weimar

April–September 2023

Iryna Kashtalian received her bachelor's degree in history at the Belarusian State University in Minsk, her master's degree in political science at the European Humanities University in Vilnius, and then studied at the Institute for Eastern European Studies at the Free University of Berlin for her PhD. She was a member of the Non-State Archive for Modern History and a research associate at the Belarusian Scientific Research Center for Electronic Documentation, both located in Minsk. Together with her team, she created the Belarusian Oral History Archive, and she was the head of the Historical Workshop Leonid Levin in Minsk. Before joining THE NEW INSTITUTE, Iryna was a postdoctoral fellow at the Institute of European Studies at the University of Bremen. Since November 2023, Iryna is a scientific researcher at the Buchenwald Memorial where she prepares a new permanent exhibition about Soviet Camp 2 (1945–1950).



**Project: The Future of Historical Research in Belarus: Developing Mechanisms for Preservation and Development**

The project was launched in collaboration with the Institute for Policy Research “Political Sphere” and the Belarusian Institute of Public History. As historical research in Belarus is in crisis due to the authoritarian regime’s desire to manipulate the past, to instrumentalize history for ideological purposes and to establish complete control over academic science and scholars, the project’s objective is to develop mechanisms to support historical research in Belarus, and to preserve and develop the community of Belarusian historians outside Belarus.

The project focuses on exploring the perspectives of Belarusian historians through an oral history approach and an analysis of historical papers published over the last 10–15 years, aiming to identify positive scenarios for the future of historical studies and the community of historians in Belarus.

Repressive pressures increased after the defeat of the 2020 protests. Many Belarusian historians faced increasing risks, and numerous scholars were forced to leave the country due to threats linked to their professional activities and political views. The manipulation of history for ideological purposes, publication bans, and censorship severely obstruct the development of historical science within the country.

Historians who emigrated encountered new challenges abroad: adapting to foreign academic environments, maintaining professional activities, and continuing research on Belarusian history, which is not always a priority. In response, initiatives like the Belarusian Institute of Public History were created to support and promote Belarusian historical topics outside Belarus.

The project’s primary goal was to assist the historian community in addressing these challenges, building a common vision, and suggesting potential solutions. Initially, it analyzed the current state of historical research on Belarusian topics and examined the situation of historians from Belarus in exile. Two studies were conducted: a review of Belarusian historical publications, books, and dissertations from the last 20 years. This analysis highlights development trends and offers comparisons with other academic fields. Subsequent research focused on the forced emigration of historians and the evaluation of international support programs. These studies revealed specific migration patterns, available forms of support, and long-term challenges faced by historians abroad. Additionally, a series of interviews with historians was conducted, featuring biographical and thematic sections. These interviews provided insights

into historians’ views on the future of historical science, education, the academic community, and the effectiveness of support structures for scholars in exile.

The collected materials serve to analyze the state of historical science on Belarusian topics and are the basis for developing recommendations on how to overcome the current crisis in research, which has significantly deepened after 2020. The project team is currently preparing a policy paper summarizing the research findings and recommendations.

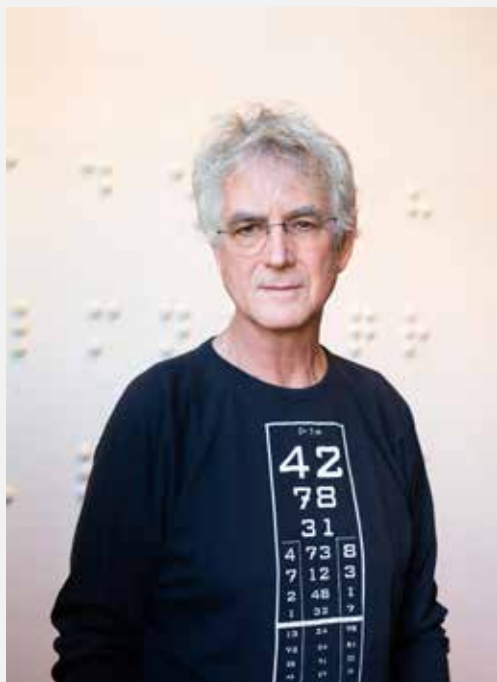
Additionally, several events in September 2024 and March 2025 were organized involving historians, experts, academic institution representatives, and other stakeholders. Participants discussed how to maintain independent historical research and counter the instrumentalization of Belarusian history. The project team also produced a series of educational video programs for the “Complex History” YouTube channel, aiming to popularize Belarusian historical knowledge and address current issues in an accessible format.

The final output of the project will be an analytical note (policy paper) providing recommendations for stakeholders, social and political organizations, and potential donors. Its overarching goal is to preserve, support, and foster the further development of Belarusian historical scholarship and the community of historians under the new conditions.

Freeszfe Society, Budapest

October 2022–June 2023

László Upor is a dramaturg, literary translator, essayist, and university professor. He specializes in contemporary drama and performing arts. He has worked both with mainstream companies and with a great number of independent artists, in physical and puppet theaters. He has published three books and numerous articles on theater, film, and contemporary circus. His translations include novels, non-fiction, and over fifty stage plays. He is former Vice Rector/ Acting Rector of University of Theater and Film Arts (SzFE) in Budapest where he taught for over three decades. His third book is a personal account of the SzFE / Freeszfe autonomy fight.



### **Project: Freeszfe Society: Further Development into a Transnational, Transcultural Institution**

Laslo Upor is a founding member of Freeszfe Society, formed by students and faculty who left SzFE after a long battle with the Hungarian government in 2021. He used his Elkana Grant to further address social issues through the work of the Freeszfe Society.

In November 2024, the Freeszfe Society organized an International Conference on Art and Activism in Budapest, which explored the dynamic and multifaceted relationship between politics and theater, with a central focus on how art functions within, responds to, and shapes societal and political realities. It emphasized the idea that theater is not merely a reflection of the world but an active participant in its transformation. Discussions highlighted the role of art as a vehicle for political engagement, social critique, and public discourse.

A key theme was the power of artistic expression to challenge dominant systems and foster dialogue. The notion of participatory and community-based art emerged as a critical tool for addressing social issues, enabling artists to engage directly with public spaces and marginalized communities. These forms of art were shown to spark civic awareness, encourage activism, and influence cultural perceptions.

The conference also examined the responsibilities that artists carry in public life, balancing personal expression with societal expectations. Exhibitions, performances, and archives were discussed as powerful mediums for political commentary, capable of uncovering suppressed histories and generating new forms of social engagement.

Another important focus was the aesthetics and strategies of protest within artistic practice. The sessions delved into how creative methods can mobilize communities, transform spectators into participants, and document resistance as both an artistic and historical act. Art was portrayed as a vital form of resistance, capable of energizing movements, preserving their legacies, and continuously questioning the status quo.

Overall, the conference reinforced the view that political theater and socially engaged art are essential tools in the pursuit of equity, visibility, and systemic change, positioning artists as storytellers and agents of transformation.

Additionally, Freeszfe Society presented a project at the 2024 Budapest Spring Festival titled “The Island of Peace: A Grandiose Artistic Experiment,” and involved more than 100

artists, visual designers, film and theater directors, cinematographers, and musicians.

The Elkana Grant also allowed Freeszfe Society to support a student's graduate film production "Stars of Little Importance," which explored the question of what comes next when one is no longer a child but has yet to become an adult. With its Hungarian and international partners, Freeszfe Society continues to work on creating an independent transnational collective by administering, mentoring, and, with its limited resources, financing three independent theatre projects by young emerging artists exploring burning topics of social and global issues.

## Institutional Publications

Our series **THE NEW** publishes collaborative research in the humanities and social sciences. The second book in this series, *Seeds for Democratic Futures*, was published in November 2024. The 17 essays in *Seeds* were written by former fellows at **THE NEW INSTITUTE** and investigate potentials for democratizing democracies. From finding faith to reclaiming the commons, each essay aims to plant a seed, which carries the promise of democratic potential. Dealing with topics like planetary change, AI, and plural knowledge systems, the book acts as an inspiration, calling for unorthodox, compassionate, and experimental approaches.

A German edition of *Seeds for Democratic Futures* is forthcoming in Autumn 2025, as is the third volume in the series **THE NEW**, which will address the 2024–2025 annual theme of Re-thinking Capitalism.

The goal of the series is to make humanistic research relevant and accessible to wider audiences, and to that end all of our publications are available as Open Access publications through our publisher transcript.

## FILMS

Over the past years, several of our fellows have collaborated on acclaimed documentary film projects, notably with ARTE. A central highlight is the ongoing series “Unhappy”, which explores nuanced approaches to happiness and well-being through in-depth conversations with thinkers and creatives from various fields.



In previous seasons, our fellows Ruth Chang and Avram Alpert contributed thought-provoking perspectives to episodes examining the philosophy and practicalities of happiness. The current season, available since January 2025 on ARTE Mediathek and YouTube, features fellows Wakanyi Hoffman, Avram Alpert, and Karma Ura in episodes “*Vom guten Schlaf*” and “*Die gute Beziehung*.” These installments address themes such as the art of restful sleep and the foundations of healthy relationships, offering viewers accessible guidance for enriching everyday life.



This year's episodes have further broadened the discussion, with fellow Minna Salami drawing on her influential work *Sensuous Knowledge* to address the importance of sensuality and embodied wisdom in living well, while seeking to redefine our relationship to body and senses in a non-political, advice-oriented format.

Fritz Breithaupt has now joined the series, offering his perspective on topics like aging, self-confidence, memory, family stories, finding happiness in cities, and the deeper layers of empathy and conflict. His insights add thoughtful depth to the conversation, touching on the intricate realities that define our daily lives.

Vivien A. Schmidt

With its recent reform of the fiscal rules of the Eurozone's Stability and Growth Pact, suspended during the Covid-19 pandemic, the EU has gone back to "governing by rules and ruling by numbers." These fiscal rules, together with the failure to add any significant new EU level fiscal capacity, leave the EU unable to address its many challenges in terms of climate change, social inequality, and security. Not only do such deficit and debt targeting rules spell austerity for many EU member-states, they also stand to aggravate social problems and increase political discontent. Legitimacy, so much in question during the Eurozone crisis, is likely again to be at risk, and to fuel even more populist backlash. So how do we explain why EU economic governance is still not fit for purpose? The talk highlighted "grand theories" of European integration, provided insight into economic governance during the Eurozone and Covid-19, considered the flaws of the current reform, and pointed out potential remedies.

Vivian A. Schmidt is Jean Monnet Professor of European Integration, Professor Emerita at Boston University and Visiting Fellow at the Schuman Center at European University Institute in Italy.

**05.03.25****Food as a Commons**

José Luis Vivero

Departing from the dominant valuation of food as a commodity that is so pervasive in the industrial food system, Jose Luis Vivero deconstructed the idea of food as a for-profit commodity and framed it as a commons, a public good, and a human right. The rationale is based on (a) its essential nature for every human being, (b) the multidimensionality of food that cannot be fully valued in monetary terms, and (c) the many real-life examples, throughout history and today, that prove that all societies have treated food as a commons and a public good. The absolute commodification of food is therefore a historical anomaly

Jose Luis Vivero is a humanitarian professional serving the World Food Program. As a food systems thinker, committed scholar and anti-hunger activist with 25 years of experience in food and nutrition security policy, the right to food and food sovereignty, he has conducted research on agri-food transitions, narratives and practices to consider "food as a commons and a public good" and not simply a commodity. He is one of the editors of the *Routledge Handbook on Food as a Commons* (2019) and his research focuses on territories of commons in Europe, the monitoring of food system transitions, and resilient food systems in fragile environments.

**12.06.25****Inside the Ideological Brain**

Leor Zmigrod

This talk explored the possibility that some individuals are particularly susceptible to extreme worldviews and how features of their brains and everyday thought patterns can propel people towards rigid belief systems. Through research in the new field of “political neuroscience” it has become evident that there are psychological and even neurobiological differences between adherents to different ideologies, and that our brains come to reflect the ideologies we hold in real and striking ways. The stakes of embracing an extreme ideology are much higher than we typically assume: if our brains and bodies echo our ideologies, then extremism is not just a political issue, it is also a profoundly personal and existential problem. It is increasingly urgent to think deeply about the origins of ideological convictions and the consequences of adopting binary worldviews, as well as what it means to think and exist flexibly in a world determined to position us in narrow boxes.

Leor Zmigrod is a political psychologist and neuroscientist investigating whether some brains are susceptible to extreme ideologies and how minds can break free from rigid dogmas.

Sustainable consumption and green growth—can such measures stop climate change? Kohei Saito says they can't. In his book *Capital in the Anthropocene*, he demonstrates how the foundations of capitalism inhabit the basic logics of an exploitation of humanity and nature. He argues for systemic change founded in democratically managed common goods. Combining his ideas with readings of Karl Marx, he arrives at the concept of degrowth—a way of living that dismisses the centrality of production and consumption. These are questions that are also discussed on theatre stages, and Joachim Lux and Christina Bellinghen engaged with Saito on his utopian theory in the context of Thalia Theater's production of American author T.C. Boyle's dystopian *Blue Skies*.

**22.05.25****Helmut-Schmidt-Zukunftspreis: Award Ceremony at Thalia Theater**

THE NEW INSTITUTE, in collaboration with the Federal Chancellor Helmut Schmidt Foundation and DIE ZEIT, awarded the annual Helmut Schmidt Future Prize at the Thalia Theater. For the first time, two individuals were jointly awarded: German choreographer and director Sasha Waltz, and Danish artist and architect Ólafur Elíasson. Their cultural contributions were recognized for advancing democracy, environmental protection, and liberal values, following past laureates Vanessa Nakate, Sanna Marin, and Meredith Whittaker. This year's jury included chairman Uwe Jean Heuser (DIE ZEIT), Alexander Birken (Otto Group), Antje Boetius (Alfred-Wegener-Institut), Francesca Bria (Italian National Innovation Fund), Sanna Marin, Vanessa Nakate, Anna Katsman (THE NEW INSTITUTE), Meredith Whittaker (Signal), and Meik Woyke (Helmut Schmidt Foundation).

The jury described Sasha Waltz weaving “social issues into her art in a very human way. From ‘Allee der Kosmonauten,’ where she explored life in a high-rise neighborhood, to the ‘Dialogues’ series, and more recently in ‘In C,’ she responds to the attacks on democracy by focusing on empathy and human connection.”

Regarding Ólafur Elíasson, the jury said: “Ólafur Elíasson’s works remind people all over the world of their responsibility for the environment, while creating shared experiences through art in a way that’s almost unique. He counters the trend of focusing on the national or the individual with a vision of a society that cares and engages in dialogue, even challenging boundaries within the commercial space. You can see this in his projects like the giant sun in the Tate Modern in London in 2003 and 2004, where he brought two million people together.”

**Book talk: Bodenschätze**

This book talk was held at Felix Jud Bookstore with the author Isabel Feichtner as well as Tim Wihl (University of Erfurt) and Maximilian Petras (Helmut Schmidt University Hamburg). In her new book, Feichtner sheds light on the question of who owns the soil, whether it's in a city on land or in the sea: "For decades, urban soil has been privatized, and the ocean floor is also being exploited. Companies want to mine minerals in the deep sea that are needed for the batteries of electric cars. Residential real estate and deep-sea minerals have become investment properties, and the exploitation of the soil has far-reaching social implications. Even if the two places are very far apart, the processes of their exploitation and valuation allow us to negotiate fundamental questions of our present. And resistance is growing....coalitions are forming against deep seabed mining. Counter-rights are being mobilized against the exploitation of soil, and it is becoming clear how habitability could become the focus of a planetary policy."

**On Breathing and Collapse: Book Discussion with Aris Komporozos-Athanasίου and Jamieson Webster**

This discussion between sociologist Aris Komporozos-Athanasίου and psychoanalyst Jamieson Webster was about Webster's new book *On Breathing*, a searching and poetic reflection on the psychic, political, and bodily dimensions of breath. It draws on philosophy, psychoanalysis, and personal experience to explore what it means to breathe in a world that so often constricts us.

As part of their collaboration on the *Futures of Capitalism* program, Komporozos-Athanasίου and Webster also reflected on what it means to "put capitalism on the couch"—probing collective denial, shared vulnerabilities, and the psychic contours of planetary collapse. Did psychoanalysis sense the breakdown before the markets did? Was the real myth not collapse, but the sense of coherence we imagined had come before it?

# COOPERATIONS & PARTNERSHIPS

Throughout the 2024–2025 academic year, we continued to foster collaborations and cultivate long-term partnerships with actors from academia, civil society, politics, and business. Below is a selection of institutions we have worked with.

## Centers

Erck Rickmers' commitment to fostering academic and societal change began well before the founding of THE NEW INSTITUTE in Hamburg. He supported the creation of several university research centers dedicated to exploring the nexus between scholarly work and social transformation.

### **THE NEW INSTITUTE's Centre for Social Critique at Humboldt University Berlin, Germany (until 2028)**

The Berlin Centre builds on the tradition of critical theory and is led by political philosopher Rahel Jaeggi. Its focus lies on examining the past and present pathologies of capitalism in order to explore how social change can be effectively pursued in an era of growing inequality.

### **THE NEW INSTITUTE's Centre for Environmental Humanities at Ca'Foscari University Venice, Italy (until March 2025)**

The Venice Centre focuses on the environmental humanities, with its research deeply rooted in the unique history and ecological challenges of Venice. Under the leadership of Francesca Tarocco, a scholar specializing in the intersection of Buddhist and Asian Studies, the program engages with these themes to address the city's environmental issues.

## Yehudit and Yehuda Elkana Fellowship

Established in collaboration with the Wissenschaftskolleg zu Berlin, the Yehudit and Yehuda Elkana Fellowship offers researchers committed to the free exchange of knowledge and the promotion of academic debate the opportunity to spend three to six months at either THE NEW INSTITUTE in Hamburg or the Wissenschaftskolleg zu Berlin.

## Helmut-Schmidt-Zukunftspreis (Helmut Schmidt Future Prize)

In 2025, THE NEW INSTITUTE, in collaboration with the Federal Chancellor Helmut Schmidt Foundation and DIE ZEIT, continued presenting the Helmut Schmidt Future Prize, an annual award recognizing innovative achievements in the fields of democracy, society, and technology. Following in the footsteps

of Ugandan activist and social entrepreneur Vanessa Nakate, Finnish politician Sanna Marin, and technology advocate Meredith Whittaker, this year marked the first time that two individuals were honored with the Helmut Schmidt Future Prize: German choreographer, dancer, and director Sasha Waltz, and Danish visual artist, designer, and public space architect Ólafur Eliásson. They were recognized for their cultural innovations that promoted the protection of democracy and nature, as well as for their commitment to a liberal society.

In 2025, the jury of the Helmut Schmidt Future Prize consisted of: Jury chairman Uwe Jean Heuser (DIE ZEIT), Alexander Birken (CEO of Otto Group), Antje Boetius (Director of the Alfred-Wegener-Institut at the Helmholtz Centre for Polar and Marine Research), Francesca Bria (President of the Italian National Innovation Fund), Sanna Marin (Former Prime Minister of Finland, advisor for the Tony Blair Institute for Global Change), Vanessa Nakate (climate activist and social entrepreneur), Anna Katsman (Academic Director of THE NEW INSTITUTE), Meredith Whittaker (President of Signal), and Meik Woyke (Chairman and CEO of the Bundeskanzler-Helmut-Schmidt-Stiftung).



## Hamburg Sustainability Conference

In the 2024–2025 academic year, THE NEW INSTITUTE partnered with the inaugural Hamburg Sustainability Conference—an international forum convening leaders from politics, business, science, and civil society to shape the global sustainability agenda. Opened by German Chancellor Olaf Scholz, the conference was co-hosted by the Federal Ministry for Economic Cooperation and Development, the UN Development Programme, the Michael Otto Foundation, and the City of Hamburg.

In addition to several fellows participating in the main program, THE NEW INSTITUTE curated a dedicated event in 2024 titled “How to Make Food Systems Better for People and Planet.” The session gathered voices from science, policy, and activism to address the urgent need for more sustainable, equitable, and resilient food systems.



In 2025, THE NEW INSTITUTE hosted a public panel, “Governance Innovations to Address Earth System Risks,” featuring leading scientists and policymakers on Earth system risks and planetary boundaries. In collaboration with TMG Research, it also organized “Working with Informality: Food, Livelihoods, and the Path to Resilient Communities,” exploring informal economies—from school feeding to food vending and community-based aid.

Through its involvement, THE NEW INSTITUTE reaffirmed its commitment to interdisciplinary dialogue and practical action at the intersection of ecological transformation, social justice, and global governance.

## Integrity Initiatives International

Since 2023, THE NEW INSTITUTE has partnered with Integrity Initiatives International, a non-governmental organization dedicated to fighting grand corruption and advancing the creation of an International Anti-Corruption Court to tackle global economic crime. THE NEW INSTITUTE is proud to support the efforts to draft a model treaty for the future International Anti-Corruption Court by hosting its biannual treaty committee meetings. International jurists, lawyers, scholars, and anti-corruption experts from across the globe convene at THE NEW INSTITUTE to form the draft model treaty as a foundation for public discussions among governments, civil society, and the private sector on how to establish an effective International Anti-Corruption Court.

The Felix Jud Bookstore in THE NEW INSTITUTE is an international, multi-perspective, transdisciplinary bookstore with a focus on questions of ecology, new forms of economy, democratic innovation and concepts for a better world.

Since moving into our institute building in 2022, we have been cooperating with the Hamburg bookstore Felix Jud, which operates the Felix Jud Bookstore in the Warburg Ensemble. In close collaboration with our library, the bookstore's stock is intended to provide insight into the themes of the Institute's programs. Above all, however, the bookstore hosts public, low-key events in which the fellows' brief contributions are merely an invitation to a conversation in a relaxed atmosphere. Experimenting with new formats all the time, in 2024, we introduced our latest feature, a monthly Reading Club, which proved immensely popular with fellows and external guests. As a little twist and challenge for ourselves, we read through various literary genres over a six-month period.

For four years, the media team has been THE NEW INSTITUTE's storytellers, sharing ideas and building bridges between our fellows' work and the world. We focused on narratives of change, not just theories of change. ## Newsletters

Through *The Update*, we offered monthly snapshots of the Institute’s activities, including event highlights, fellow spotlights, sources of inspiration, and curated reading lists. We also documented how our fellows’ projects took shape throughout the year. As our international fellow community grew, so did our readership, reaching over 10,500 subscribers.

In the *Re-thinking Capitalism* newsletter series, our media fellow Felix Rohrbeck brought our research to life, cutting through academic jargon to ask, “What’s broken? What’s being tested? What could change?” Each edition offered a glimpse into the journeys of our fellows as they challenged the status quo. Examples include José Luis Chicoma, who transformed his experience as Peru’s Minister of Production into a blueprint for food justice; Kohei Saito, who reimagined economic planning for a post-growth world; and Maja Groff, who campaigned for an International Environmental Court with real power. 01 Can Feminism be African?

Is one of the questions that has been on our minds since last academic year, when [Minna Salami](#) led our [Black Feminism](#) program. Now she has written – and recently published – a book about this most paradoxical question.

But for a Japanese philosopher [Kohei Saito](#) that doesn’t go far enough—of the climate crisis. In November 2024 we published *Seeds for Democratic Futures*, the second volume in our book series THE NEW. The 17 essays in *Seeds* were written by former fellows at THE NEW INSTITUTE and represent a bold call to rethink what democracy can and should be. Covering topics from law and social movements to digitization, ecology, climate change, and artificial intelligence, the contributors offer both theoretical insights and hands-on ideas. Each essay plants a seed with the hope of renewing and strengthening democracy or sparking new democratic possibilities. But the book doesn't merely ask how to fix democracy, it asks what it takes to grow something better. *Seeds for Democratic Futures* encourages creative, compassionate, and unconventional approaches, inviting readers to imagine and build democratic futures that are as diverse, resilient, and vibrant as the people they are meant to serve.

A German edition of *Seeds for Democratic Futures* is forthcoming, as is the third volume of the series THE NEW, which will address the 2024–2025 annual theme of Re-thinking Capitalism. The goal of the series is to make humanistic research relevant and accessible to wider audiences, and all of our publications are available as Open Access publications via transcript Verlag.



## Film

At THE NEW INSTITUTE, filmmaking is woven into our mission to amplify dialogue and drive transformation. For us, the moving image is not just a tool for documentation; it is a means of reflection, questioning and reimagining our shared realities. We conceive each film project as an invitation to explore the intersection between research and lived experience, to shed light on the choices that define our era and to initiate the conversations that are essential for meaningful change.

Our productions go beyond recording events; they actively reveal the connections between the work of our fellows and the urgent issues shaping society today. Through them, complex ideas circulate – dynamic and alive – encouraging viewers to reconsider prevailing narratives and to envision new possibilities. We see every film as an opportunity to expand the boundaries of what is possible, inspiring thoughtful engagement and collective action within and beyond our community.



## One Idea 60 Seconds

Each idea is its own act of resistance against the tyranny of complexity. In sixty seconds, our fellows – economists, philosophers, biologists – distill the essence of their research into a statement, a provocation, a window into another way of seeing. From Onya Idoko's meditation on balancing priorities in collective business enterprises to Fritz Breithaupt's exploration of why stories matter, these shorts are proof: transformation can begin with a sentence, a gesture, a look into the lens. Shared across social media channels, the series became a living archive of the myriad energies animating the institute over the past year. Here, brevity is not limitation but liberation, a form of radical clarity.

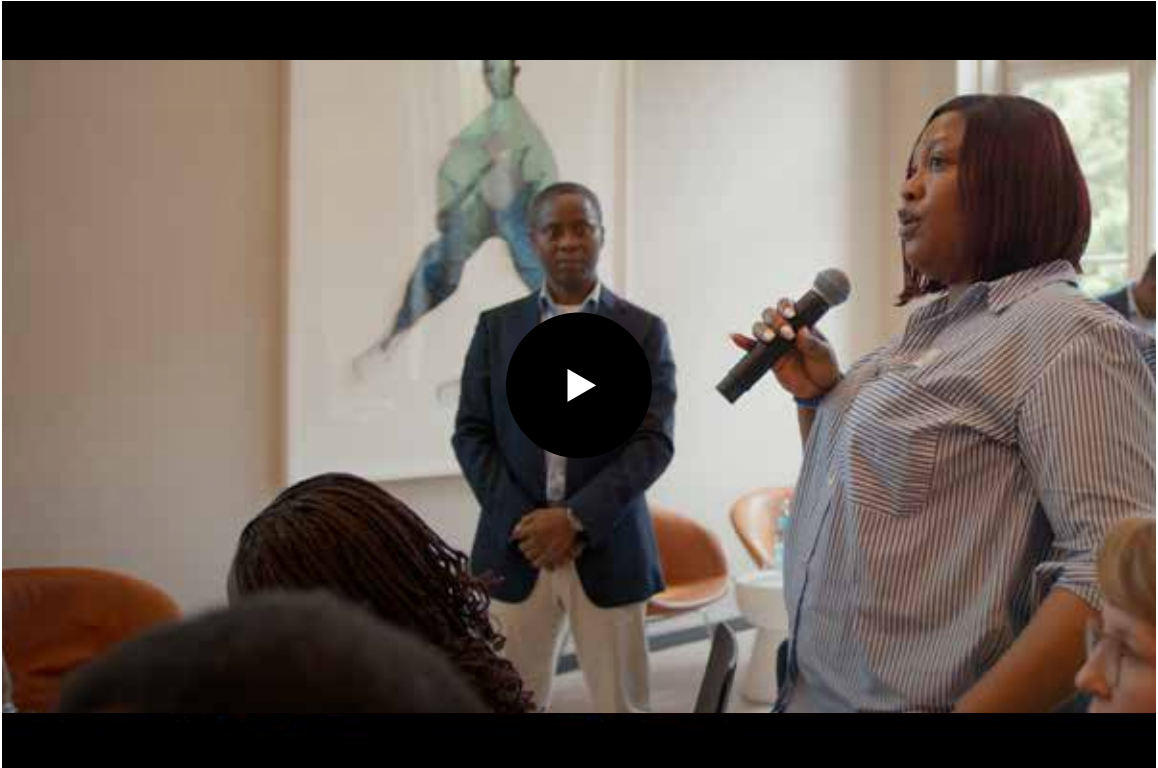
## Interviews

We seek out conversations that are alive with tension and hope, and dialogues that refuse easy closure. Zeynep Alemdar brings together thinkers for urgent discussions on academic freedom, while Jay Bernstein talks to our Academic Director, Anna Katsman, about climate catastrophe and emerging forms of solidarity. These recordings are interventions designed to travel beyond the walls of the Institute and stimulate thought wherever they are heard.



## Project Films

At the intersection of story and action stand our project films. At the Africapitalism Conference, the future felt tangible for a moment: shared entrepreneurship, the OKOBI model, the determination of communities in Nigeria, Kenya, and beyond to redefine the continent's destiny. The camera acts as both witness and companion, neither glossing over contradictions nor simplifying complexity, but rather tracing its arc – from roundtable debates to lived realities. The film documents not consensus, but the possibility of movement. What would it take to build an economy grounded in dignity and trust rather than extraction and dependency?



In our film on the Future of Food Advisory Committee Meeting, the stakes are ecological collapse, global malnutrition, entrenched inequity. The medium captures not only the gravity of the challenge but also the optimism and urgency of the experts gathered in Hamburg, who imagine food systems where sustainability, health, and justice are inseparable.



These films, like all our media, are invitations. To slow down, look closely, and become unsettled – in the best way. Conversation is the catalyst for positive change.

LIBRARY

The library aims to facilitate knowledge creation within the Institute. Consequently, we see ourselves primarily as a service facility that provides any type of requested information straight away and also handles research requests on specific topics or compiles bibliographies. At the same time, the library is also a physical space housing a collection of analogue books, creating the “full library atmosphere”. This curated and customized selection of print (but also digital) resources reflects the current work at the Institute—hence the strong accent on the humanities and social sciences.

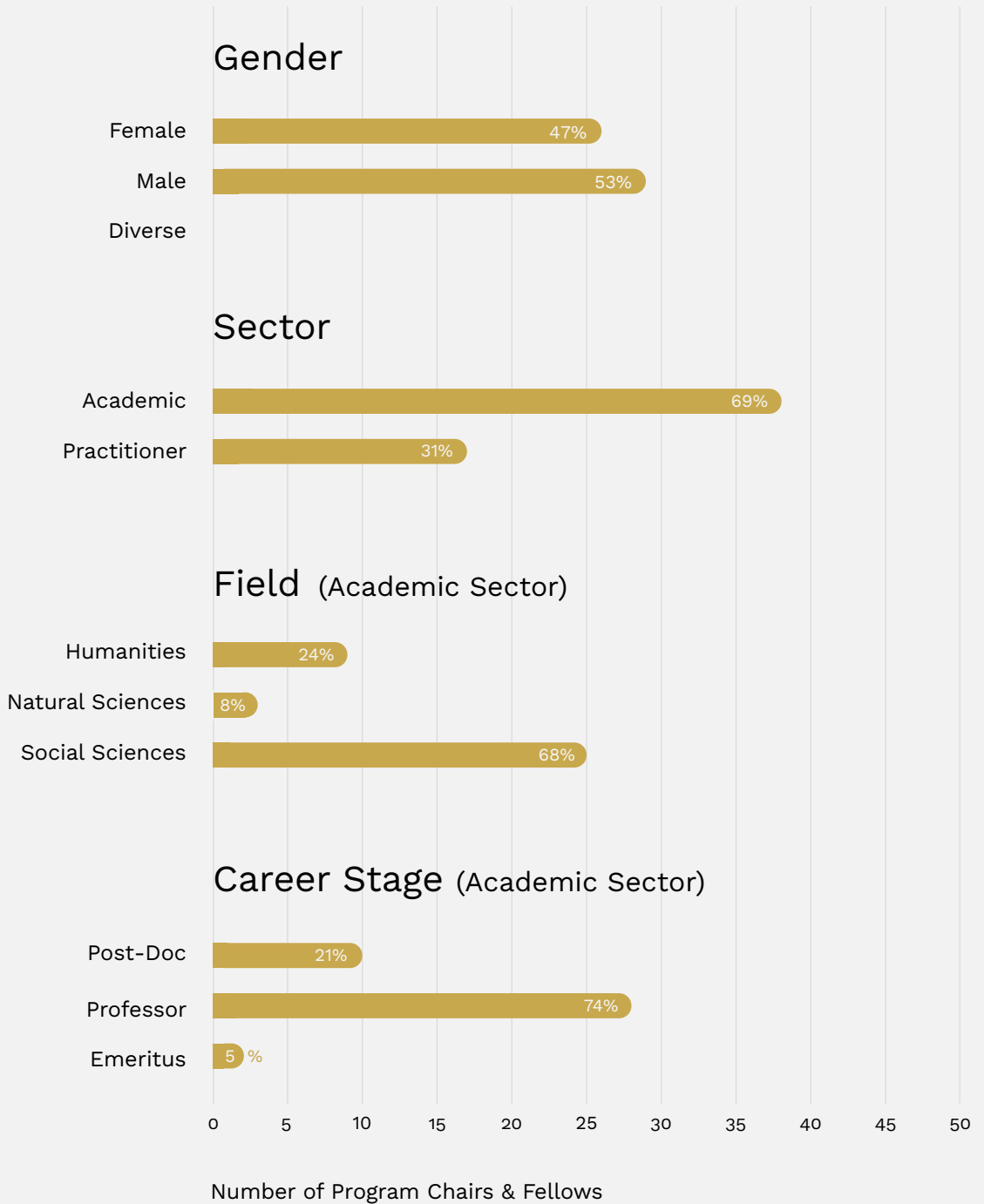
Yet, our overarching focus, which also integrates selected titles from the natural sciences on the one hand and works of fiction and art on the other, is designed so to inspire fellows to look beyond the focus of their own research. And, most important, although our ambition is to ensure that timely and relevant titles are already in stock before they are requested, we consider our library a joint endeavor that grows and develops together and in close dialogue with the community. Our collection is constantly growing and comprised almost 3,000 physical books by June 2025.

As a public event, our library team established a monthly Reading Club at Felix Jud Bookstore with alternating genres, reading novels as well as short stories and poetry. Titles discussed were *Concerning the Future* of Souls by Joy Williams, *Clear* by Carys Davies, *Middlemarch* by George Eliot, *Revolutionary Petunias* by Alice Walker, *The Empusium* by Olga Tokarczuk, and *I Who Have Never Known Men* by Jacqueline Harpman.

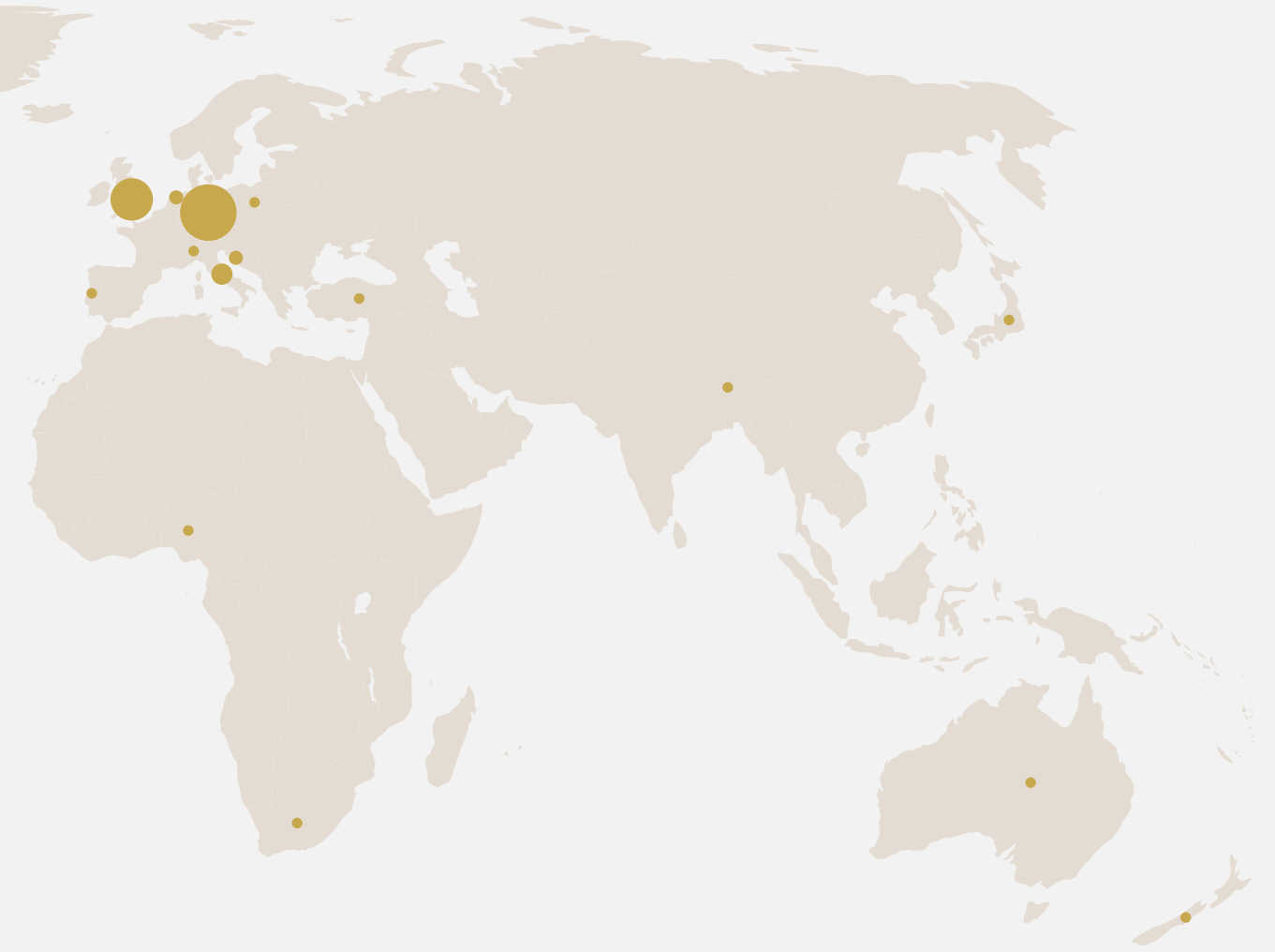

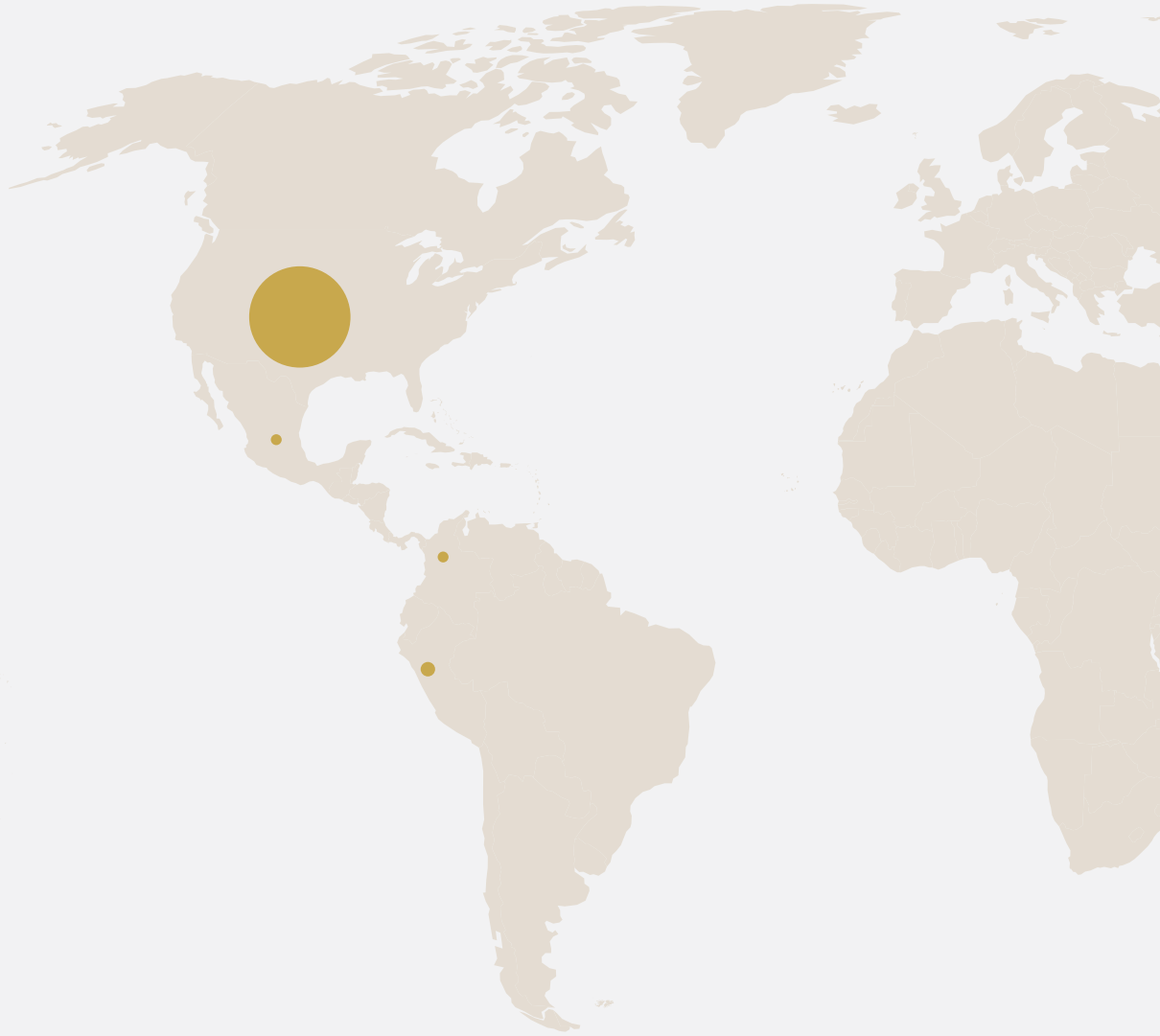
